

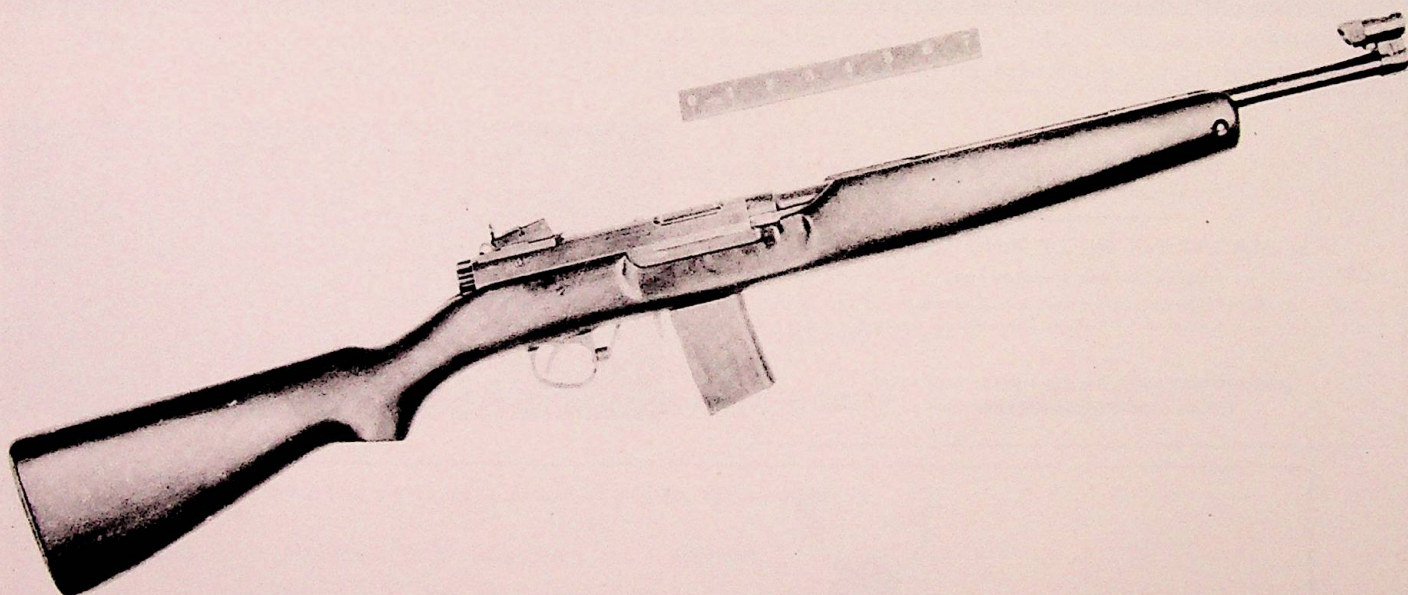

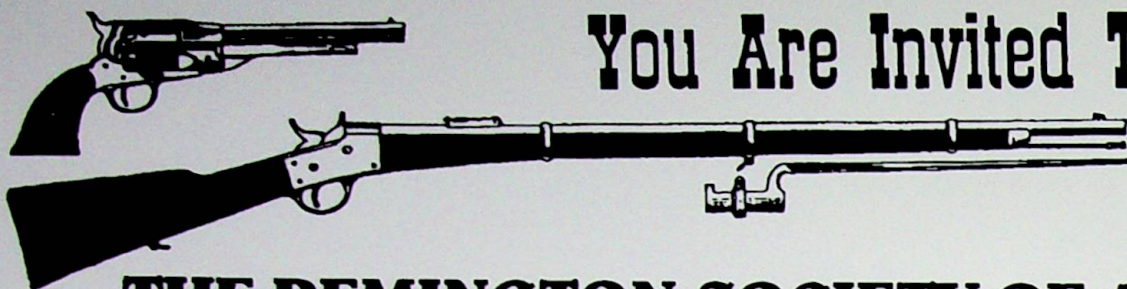

Sections on primary martial longarms (trapdoor, Krag, M1903, M1922, M1 rifles, and M1/M2 carbines), secondary martial longarms (Civil War carbines), Colt firearms (percussion, SAA, DA .38, M1911, Pocket Automatics, and DA .45), Remingtons (percussion revolvers, Lee rifles, shotguns, and gallery practice rifles), Sharps rifles and carbines, Smith & Wesson revolvers, and Winchester arms (Lever action rifles and carbines, Winchester-Lee Navy rifles, Model 54 and 70 rifles, gallery practice rifles, and shotguns), and miscellaneous weapons — over 84,000 entries altogether. ### SERIAL NUMBER CD-ROM

We have compiled serial number data on numerous U.S. martial arms, and this is being published in our *Serial Numbers of U.S. Martial Arms* series. This data is additionally available on floppy diskette and CD-ROM, for those who have access to personal computers.

The CD-ROM contains a menu system that allows you to select the type of data he is interested in viewing, plus a data management system that allows you to browse through the data, find a given serial number (or its absence), and search for character strings of interest.

The data are organized into a number of files, corresponding to the type of weapon. Following are the files that are presently included:

## Miscellaneous News and Notes

### Research During This Period

There has been another big move at the Archives, with all records starting with WWI being transferred to College Park. Records are of course unavailable during the move, so this has caused me to discontinue research in the WWI unit records.

Also, the Civil War unit regimental books that I straightened out last year seem to have gotten screwed up as bad as they were before then, as a result of the failure of the Military Reference branch to adopt my recommendation of limiting "pulls" to 1 regiment per cart. I have copied out many of the soldier names, but I am still getting requests for data I don't have that has been misfiled.

I have continued going through the early military records of the Quartermaster Department and have covered more than 400 volumes in "Masterson's List". I added a file HFERRY.N89 to the serial number database, containing the two musket numbers I have found so far; and I hope to find more during the coming period.

I'm up to Illinois in the Civil War muster rolls; finding only a few serial numbers, but adding quite a bit of information to my files of types of weapons on hand in cavalry units.

### Maryland State Archives

I spent a day going through military records in the Maryland State Archives. A very pleasant facility, but I can't say I recommend it to a researcher intent on going through a large volume of records in a limited time: mostly my problem, tho, for waiting too long to complain to the manager about the poor service.

Lots of rosters of military equipment, invoices from SA and RIA for cal. .45 rifles, and other documents that should list serial numbers, but I didn't find a single one.

Only a few items of interest, e.g., purchase of 10,000 muskets from Poultney & Trimble in 1867/68; receipt of 379 M1870 rifles in 1874, that were shipped to the 5th Regt Armory (maybe the same Armory where we used to have the Balto. Gun Show?); Maryland issuing cal. .45 Cadet rifles to Charlotte Hall Academy; mixed .45 and .50 rifles in National Guard units.

Lots of target records and other stuff to warm

the heart of a trapdoor aficionado.

I plan to spend at least one more day at the MSA.

### CD-ROM Database

We are planning a new product, our complete serial number databases on CD-ROM. Retail price will be \$75; however, as an introductory offer and to get some feedback from knowledgeable users, the first CD-ROM is being offered to SRS subscribers during August, 1999, for \$50. As compared to the diskettes that we have been selling, the CD-ROM will contain a complete search and retrieval system adaptable to either MS-DOS or Windows, in addition to the data. The CD-ROM will be updated annually; however, it will still be possible to update its files from quarterly diskettes.

### Bound Set Newsletters on eBay

I have come across three copies of "The First Fourty Issues" bound sets, and I plan to put them up for auction on eBay coincident with mailing of this issue (#89). They can be found under COLLECTIBLES:MILITARIA:GENERAL, or search for "newsletters". They will be put up sequentially, at five day intervals.

Incidentally, although eBay has banned the sale of complete guns, there are still plenty of accoutrements and gun parts to be bid on.

## Letters Received & Sent

### Early Stargauged Rifle

Enclosed is the S.A.S.E. per our conversation of 3-29-99 in reference to U.S. Springfield M/1903 serial # 608034 - "N.R.A." marked trigger guard, barrel is marked J46 as we discussed, this is the "Star gage #". To my knowledge, no heat lot numbers were placed on the Springfield Armory weapons. The date on this rifle is 7-15. Any information on this rifle would be greatly appreciated. The Star Gage was introduced in 1905 and was in use prior to 1921. I think that we would both agree that these N.R.A. rifles of the "SS" variety would be star gaged, the action of the above rifle has been fine tuned by stoning.

Are there any N.R.A. stargaged rifles in your archives close to this #?

The stock as I mentioned is "Presentation Grade" with full close Tiger Striping.

*Unfortunately, we have no information on no. 608034; likewise, nothing on star gauge marking practices in 1915. We have numbers on star-gauged rifles within a few thousand of yours, but none on sales rifles.*

*While I agree that the marking on your rifle probably represents the star gauge number, I do not agree that all N.R.A.-marked rifles had star-gauged barrels.*

*Following are the features of National Match rifles, as outlined in a memo dated July 20, 1915:*

- 1) Trigger pull between 4 lbs. 14 oz. and 4 lbs. 10 oz.;*
- 2) Creep is almost entirely eliminated;*
- 3) Bolts are polished;*
- 4) Chambers are reamed to finish after being assembled to the receivers;*
- 5) Upper bands are fitted so they are not too tight;*
- 6) The pressure from the bolt stop is as small as can be had with proper functioning;*
- 7) 5 drift slides .06-inch are packed with each 10 rifles;*
- 8) Barrels are star-gauged and specially selected, and they are as nearly as possible perfect cylinders measuring ".308 in diameter.*

*No new National Match rifles were manufactured in 1916. So if your rifle has its original bolt and it is not polished, it is not a National Match rifle. But it can*

*still be a star-gauged rifle, because it was possible for an N.R.A. member to purchase a rifle with star-gauged barrel for a small additional cost; I suspect that is what you have. The N.R.A.-marked '03 in my collection. s.n. 623621 with 3-16 barrel, has no star gauge mark, indicating that it was sold as a regular service-grade rifle.*

*Hopefully, this will encourage one of our readers having a rifle corresponding to 1915NM specs to peek under the handguard and let us know what he finds.*

### National Match Pistol Rebuilds

Based on my observation, all the National Match .45s rebuilt by Springfield Armory have Remington frames.

Is this a coincidence, or did the armorers do this for a reason?

*That does not appear to be correct, because I have seen nothing about it in the Ordnance records, and we have records on a number of NM rebuild pistols whose numbers fall into Colt and Ithaca serial ranges.*

### SAA 6342; M1911 NRA 125124

Some time ago the enclosed correspondence passed between us. I wonder if anything new has turned up regarding Colt SAA 6342?

Today, however, I am also interested in the following question. I have a Colt manufactured, Model 1911 pistol, serial number 125124 marked both UNITED STATES PROPERTY and N.R.A. That serial number is not one of those listed in Goddard's book *The Government Models* (page 131) as a known N.R.A. pistol. Do you know of any way I could evaluate the authenticity of this pistol?

*Sorry, close on both of these guns, but "no cigar". SAA 6342 is consecutive with a known Rough Rider revolver, no. 6343.*

*M1911 125124 is close to no. 125140, which was sold to the Schuylkill-Haven Rifle Club on June 21, 1916, and would have been marked "N.R.A.". If no. 125140 or another NRA marked pistol in this range could be found, it should be possible to compare its marking with yours under high magnification and get a scien-*



*tific opinion as to whether they were struck by the same die. I don't know of any other way to authenticate this pistol.*

**"L.E.B."**

I see that "L.E.B." has come up again. Back in October 1995 I answered a similar inquiry from a reader of Gun Report. I enclose the information and hope that you may find it useful. The book by Clausen covers this inspector and several others. It is worth a look as it lists inspectors for the 1909 as well as the 1917 revolvers, along with the semi-autos.

**L.E.B. initials are Leroy E. Briggs**

To answer the query of Mr. Della Porta in the July, 1995, "Powder Flask" L.E.B. are the initials of Capt. Leroy E. Briggs, Ordnance Reserve Corps, Army Inspector of Ordnance at Remington Arms - Bridgeport. Remington undertook the repair of the 1892-1903 series of revolvers to meet the needs of General Staff Officers during WWI.

Complete information can be found on page 192 of Charles W. Clausen's *Colt .45 Service Pistols* in a section called "Refurbished Pistols and Revolvers."

**922 M-I Conversions**

I found the letter from F.M.E. in Newsletter No. 87 to be most interesting. Like him, I also have a M1922 M-I rifle that was converted to an M-II at Benecia Arsenal with its original M-I stock left intact. The stock had neither been replaced with an M-2 nor was it recontoured and, like F.M.E.'s, was stamped "BA-JL" in an elongated, rectangular cartouche. I purchased it because it was the only one of its kind with the original stock I had ever seen. The serial number is "3517 B" and the barrel date is "12-25". There is also a "NTS 7" deeply stamped into the right side of the stock, no doubt denoting some shooting club or similar organization.

If more of these exact same conversions are observed, I wonder if they also would have the Benecia Arsenal cartouche? Previously, I had assumed most or even all of the conversion work had taken

place at Springfield Armory. Would Springfield more likely have replaced or altered the stocks if they had performed the conversion?

*I don't think that the stock would have been replaced unless it was in bad shape.*

*The records of Benecia Arsenal show that they started overhauling M1922MI rifles in Fiscal Year 1930. Bolt conversion was performed at arsenals and ordnance depots as well as at SA, but I don't think you can make a definite connection between the conversion and "BA" mark on a rifle. Perhaps if we knew the term of service of B.A. inspector "JL", this could be determined.*

**Springfield Musket Info**

I have a pair of US Springfield model 1863s, one type one and one type two. Both have locks dated 1864.

All information I have state the type one to have an 1863 dated lock. The lock on my gun looks correct with the gun. Is this possibly original or incorrect for the gun?

*The M1863 Type II, sometimes called M1864, was not approved until Dec. 17, 1863. Undoubtedly, it took Springfield several weeks to phase the Type II changes into production; so it can be expected that during the early part of January, 1864, they were still making Type I muskets, some of which used lockplates dated "1864".*

**WES 1921**

I always feel fortunate on the days I get to come home for lunch and find the latest SRN from which to learn new information. In 88-7 there is an interchange involving the tenure of WES. I have a 1921 NM '03 with a WES cartouche, which has been authenticated by Burt K. at the most recent Baltimore show. He and I inspected a similar 1921 NM '03, which Burt is confident as to its originality; that rifle also carried a WES cartouche. The serial numbers of the two items were within 1032 of each other. Based on these two rifles and their authentication by Burt K., I suggest that it is reasonable that WES was still there in 1921.

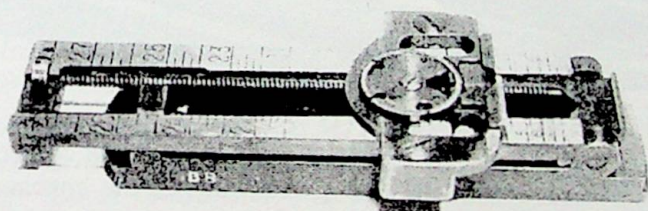

# EXPERIMENTAL BASSELL AND BLENKNER REAR SIGHT FOR MODEL 1903 RIFLE

**S**OME eleven years or so ago, in the Spring of 1988, I purchased a small box of assorted M1903 parts for \$25.00 at a local gun show. A cursory check at the time indicated the box contained a number of 1905 rear sights, bolt sleeves, grooved triggers, sears, and other small parts. The \$25.00 seemed like a really good deal. Little did I know how good a deal. When I examined the contents that evening at home, I found what appeared to be some type of special, complex and well made M1903 rifle rear sight. I had no idea as to what it actually was. A thorough check in the "Sights, Metallic" section of the expanded glossary in Lt. Col. William S. Brophy's "The Springfield 1903 Rifles" provided the answer. Pages 465 - 466 illustrate and describe an experimental rear sight for the M1903 rifle that was patented by John Y. Bassell and Fred C. Blenkner (B&B). My sight appears to have the same markings and is identical to the sight described in Brophy's text, and is shown in the 2X size photograph below.



The sight leafs are bright, and both the range and windage index markings are the same as on the standard 1905 rear sight. The left side of the base is marked "BB" and a small numeral "4" is also stamped on the base, as shown above, just to the rear of the sight leaf front lug. The drift slide has a rotating disc with five apertures, which provides a selection for any one of four .02" incrementally larger peepholes sized from .02" to .08", or a 1905 type triangular open notch. The top of the back of the drift provides a 1905 type battle sight. The drift slide fine range setting is provided by a micrometer elevation adjustment screw running the length of the right sight leaf, which is controlled by a small knob at the top. The right side of the sight leaf front lug has a clearance groove

machined for this screw. A push button on the right side of the drift slide releases it from the elevation screw and allows hand setting of large incremental range changes.

Brophy's text states that the Ordnance Department provided 5 special sights to the School of Musketry in FY1908, for tests by enlisted sharpshooters or marksmen. Brophy also states that two types of sights were tested: one sight had a 1905 type slide binding screw, and the others had the micrometer adjustment slide as described above. The latter type sight showed the most potential in these tests, and the school recommended an additional number of these B&B sights be procured and tested in service. A larger version of this sight was actually developed and approved, prior to WW1, for employment on several machine guns. I was fortunate to have held a brief discussion with Bill Brophy, on the subject of this sight, shortly after I acquired it. He was not able to provide any more depth of information, beyond that in his book. Bill noted his book points out that the original movable bases for the B&B sights used in the tests were marked "B&B" on the side. He was not aware as to whether any of the sight bases used in the tests were also numbered. The balance of our discussion actually concerned my choosing a representative M1903 to mount my B&B sight on, and about a new NRA Sporter barrel, SG# A/274 listed in his book, that I had recently acquired.

There are many unanswered questions about the B&B sight. There are two B&B sights mounted on M1903 rifles at the Springfield Armory Museum. While at the museum for this and other matters, I was not able to determine if these sights were also numbered and marked "BB". There are also B&B sights shown on 2 different rifles (assumption based on different types of handguards) in Brophy's book. These may or may not be the museum examples. How many "others" of the 5 test sights that were actually the B&B sight with the micrometer screw is unknown. On the basis of what is recorded, an assumption of 4 may or may not be safe. How many additional B&B



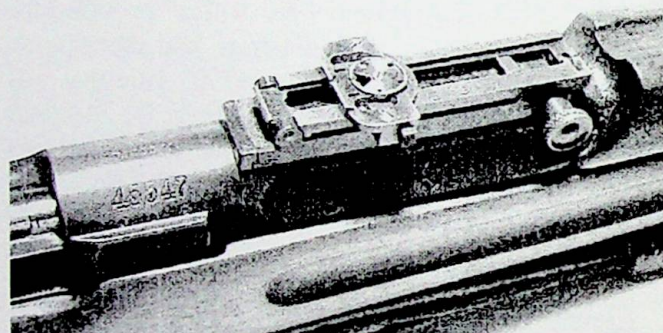
sights were procured, whether any were subsequently tested in service, and the time frame, are big unknowns. It should be noted that Clark S. Campbell briefly describes a sight test in both of his books, "The 03 Springfields" and essentially without change in "The 03 Era - When Smokeless Revolutionized U. S. Riflery" on page 41. The sight he describes has a drift slide with a rotating disk having 4 apertures and a notch. It sounds similar to the B&B, but Campbell identifies this as a "Barringer" sight and the time frame covers April 1918 to February 1919. There are no illustrations or numbers provided for the total sights involved. This is ten years after FY1908 and the School of Musketry tests of the B&B sights. There is also no way to determine whether my B&B sight was one of the FY1908 test sights. How many of these B&B sights that may exist today, is probably the biggest unknown of all. I know of 3 for sure, which could actually be 5. I would surely appreciate any information which the Newsletter Readers can provide.

Evaluation of what is known leads to some obvious conclusions. There is no question that this sight is both rare and a very valuable piece of M1903 history. I actually conducted my own side by side test of the B&B sight with the 1905 sight, on National Match M1903A1 rifle serial# 1310651, using 20 rounds each of "67" Lake City M72 match ammunition, benchrest at 100 YDS, with SR-1 targets. The B&B sight using the .08 peephole was clearly superior to the 1905. I was M-O-T 5 rounds sooner, and two 5 round 1 1/4" groups averaged 1/2" tighter. I do not consider that it was too complicated for combat, then or now. The real problems were eye placement, of course, and engineering and manufacturing costs. The B&B sight would surely fail a cost/benefits analysis.

There is also no question that this sight, or for that matter any of the many other types of experimental '03 sights, such as the Nash and Hatcher Rear Sights, never saw any general service use. Regardless of worth and utility, it appears that the tight economics of the times was the ultimate winner over all. The standard 1905 sight made it all the way to the M1903 production end, at Remington in March 1943. The Lyman 48 sight is the only other rear sight to see any extensive use, and this was on the many M1903 rifle variations other than service issue and national match.

The rifle I selected to permanently mount and

display my B&B rear sight is the earliest 1903 in my collection. It is the rifle that is closest and most representative of the rifles most likely employed at the School of Musketry for the FY1908 B&B sight tests. This rifle, by serial number reference, was probably manufactured in the early January 1905 time frame as a Rod Bayonet Rifle. It appears most likely to have been altered in the FY 1907 - 08 time frame, for all of the '05/06 modifications in one arsenal session. This included a new upper band for the 1905 knife bayonet, new front and rear type 1905 sights and bases, and rechambering from caliber .30-03 to the new Springfield .30-06 cartridge. The straight grained select American black walnut stock is the early "high walled" 1908 type without stock bolts, and it is not a modified rod bayonet type. Stock and markings are correct for the 1908 time period of the rifle. The B&B sight mounted on M1903 rifle serial number 45547 is shown in the photograph below.



The handguard as shown above is not correct to the FY1907 - 08 time period, and is the concave 1910 style. The correct handguard, with the same shape but without clips and the sight clearance groove, is on my long time "Want List". All metal parts are pre-WW1 and correct to the 1907 - 08 time period of the '05/06 modifications. The finish is blued and none of even the small parts are parkerized. I am not sure whether the 3 punch marks on the receiver ring under the serial number are spurious or maybe mean 3 trips to an arsenal. A small capital "A" under the "05" date on the barrel indicates that the rifle was overhauled, most likely incident to the '05/06 modifications, without the barrel being replaced. The rifle is pretty much the way I received it in the collection, except for the sight change. The 1905 sight I replaced was also correct to the 1907 - 08 time period and does have the small vertical platinum line bisecting the

peephole, on the aperture insert. A side profile view of this rifle, in its current configuration, is shown in the photograph above.

#### Ordinance Notes on the B&B Sight

There is probably more confusion about the Bassell & Blenkner sight than any other Ordnance development. This confusion is compounded by the virtual lack of drawings or illustrations in the records. Here is the chronology, mostly from NA RG 156, Entries 28 & 29, File 39019:

9/25/05: Several styles, including front sight and illumination, tested at SA.

4/18/06: AQMG of Ohio calls attn to B&B sight.

6/7/06: COO directs test of B&B sight.

6/27/06: Bassell requested to redesign sight.

7/31/06 SA test rpt. Recommends 1,000 slides be made for trial.

9/12/06: Cav. and Inf. Bd tests. Tested at School of Musketry (SOM) in Aug., 1907. Obscures field of view; also objects to white lines on disk. Decision: simply furnish extra .04 & .06 drift slides with M1905 sight.

9/27/06: Gen. Crozier fwds M1905 sight with dial arrangement developed at SA to AGO, for testing by Cav. and Inf. Bds in comparison with one invented by John Y. Bassell. Reports forwarded to COO 1/31/07.

10/19/06: SA submits a receiver-mounted sight similar to different designs submitted by Bassell and F. C. Blenkner "June last", upon which rpt was made in OO 39019-3. Recommends it not be applied to '03 rifle. Comments by Maj. L.M. Fuller for C. of O.:

1} Field of view too contracted

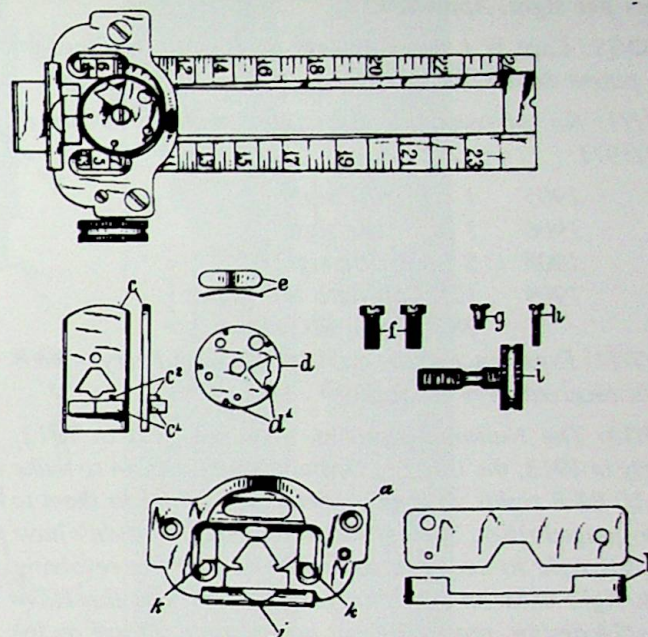
2) Delicate and unnecessarily complicated

Advantages of receiver mounting are appreciated.

4/11/07: Idea of rotating disk claimed to have originated at SA. Too complicated & expensive.

6/30/07: SA test of improved B&B sight. Recommends svc test by SOM. Patent drawing.

4/27/08: Another drawing.

12/3/08: Proceedings of Inf. Bd test of B&B sight. Favorable.

6/19/09: SA directed to prepare '03 w/ivory bead front and Bassell & Blenkner rear for Sect'y of War. Similar rifle sold to Sect'y of Navy (FDR?) about 7/28/09.

2/4/10: Proposed to use Bassell & Blenkner sights on 1,800 1910 NM rifles. SA estimates \$7.00 ea. and 4 mos. to make sights. Another est. given on lot of 6,000 -- still too high. RIA recommends that SA version of the B&B sight be adopted instead.

2/16/10: SA directed to again test B&B sight.



2/17/10: SOM comparative test.

5/9/10: James A. Drain, Editor, *Man at Arms*, raises other points such as ability to zero faster.

8/19/10: 7/19/10 Comparative test of B&B and svc rear sight. Accuracy results about equal. 378268 03 SA (B&B sight test). To be demonstrated at 1911 NM.

11/28/10: Drain apptd attorney for B&B; offers to sell rights to Gov't for \$20K. Gov't offers \$5K down and 15 cents per sight. Approved.

7/12/11: Capt W J Hawkins says B&B sight infringes on his patent 861652 of 7/30/07.

8/1/11: No. of revolving disk sights made by SA up to 7/1/1911:

1905	1 exp. rifle sight
1906	1 exp. rifle sight
1908	5 B&B rifle sights
1909	125 Colt auto MG sights
	287 Maxim MG sights

10/7/11: Experience with two rifles at Camp Perry -- B&B sight received very favorably.

6/9/13: The National Matches were not held in 1912. Early in 1913, the Chief of Ordnance directed SA to make up 10 B&B sights with micrometer screw and fit them to star-gauged rifles. Springfield stated that they didn't have a B&B sight to use as a pattern, and that the revolving disk sight used on machine guns (which was the Hawkins/SA design, not B&B) was not suitable for use on the M1903 sight of the M1903 rifle. Nevertheless, construction went forward, and 9 SG rifles with "B&B" sight were distributed as follows:

1 - OO
2 - RIA (1 for Museum)
3 - School for Small Arms Fire
2 - Manila Ordnance Depot
1 - SA Museum

Before the order for 10 had been completed, orders were placed for an additional 15 and then 25, making a total of 50 B&B sights with micrometer screw fitted to SG rifles. They were all completed about the same time, and the last 40 were shipped to troops in Hawaii and the Philippines for field trials.

June-Sept., 1913: Field trials were held, and reports submitted. Some were favorable, but the majority rejected the B&B sight based on complexity or some other factor. One trivial complaint (my opinion) was that the quick-release elevation feature did not allow the aperture to be set to an exact range mark, without using the micrometer screw. The serial numbers of 10 out of the 40 rifles used in field trials were: 544871, 544873, 544874, 544875,

544876, 544878, 544884, 544885, 544891, and 544896.

3/27/14: Bassell complains that his design was not followed by SA. Submits drawing with binding screw, no micrometer. Lack of "tiltability" (his word) in SA sight also criticised.

### My Conclusions

It appears that Bassell started out with some general ideas on gun sight design, at a time when the Ordnance Dept. was receptive to new designs. His first submissions concerned front sights and illuminated sights, and probably had nothing to do with a rotating sight disk.

It is not clear whether Bassell or Capt. Hawkins of SA came up with the idea for a rotating disk, but this device was definitely patented by Hawkins in 1907. His patent number (861652, filed Dec. 7, 1906) appears to give him priority over Bassell's patent (870337).

The Bassell and Hawkins designs differed principally in that Bassell used a binding screw to secure the disk to the slide and make elevation changes; whereas, Hawkins used a long vertical (micrometer) screw for fine adjustments and a quick-release button for coarse changes. Also, the methods of preventing the disk from rotating differed: the Bassell design required the disk to be depressed at its top side to release it, the Hawkins design did not.

SA made rotating disk sights of both Bassell and Hawkins designs between 1905 and 1913. It appears that only between 5 and 8 were of the Bassell design. More than 400 of the Hawkins design were made, mostly for use on machine guns. The 50 rotating disk sights made for star-gauged M1903 rifles in 1913 were "B&B" in name only, but were actually the Hawkins/SA design.

Brophy describes both types of sights, and he attributes both to B&B; however, while he doesn't mention Hawkins or his patent, only Hawkins-design sights are illustrated in Brophy's '03 book.

From this it seems safe to conclude that the sight that Fred found is a Hawkins or Springfield Armory sight, not a B&B — rare, but not super rare. It is most likely one of those made in 1913 — probably one of the first ten. I think it has "BB" stamped on its base because SA had been directed to make B&B sights. I would be interested to hear from collectors about other sights marked "BB".

The drawings from Hawkins' patent are shown on the following page; the actual sight differs in having the elevation screw and quick-release button on the right side instead of the left — F.M.



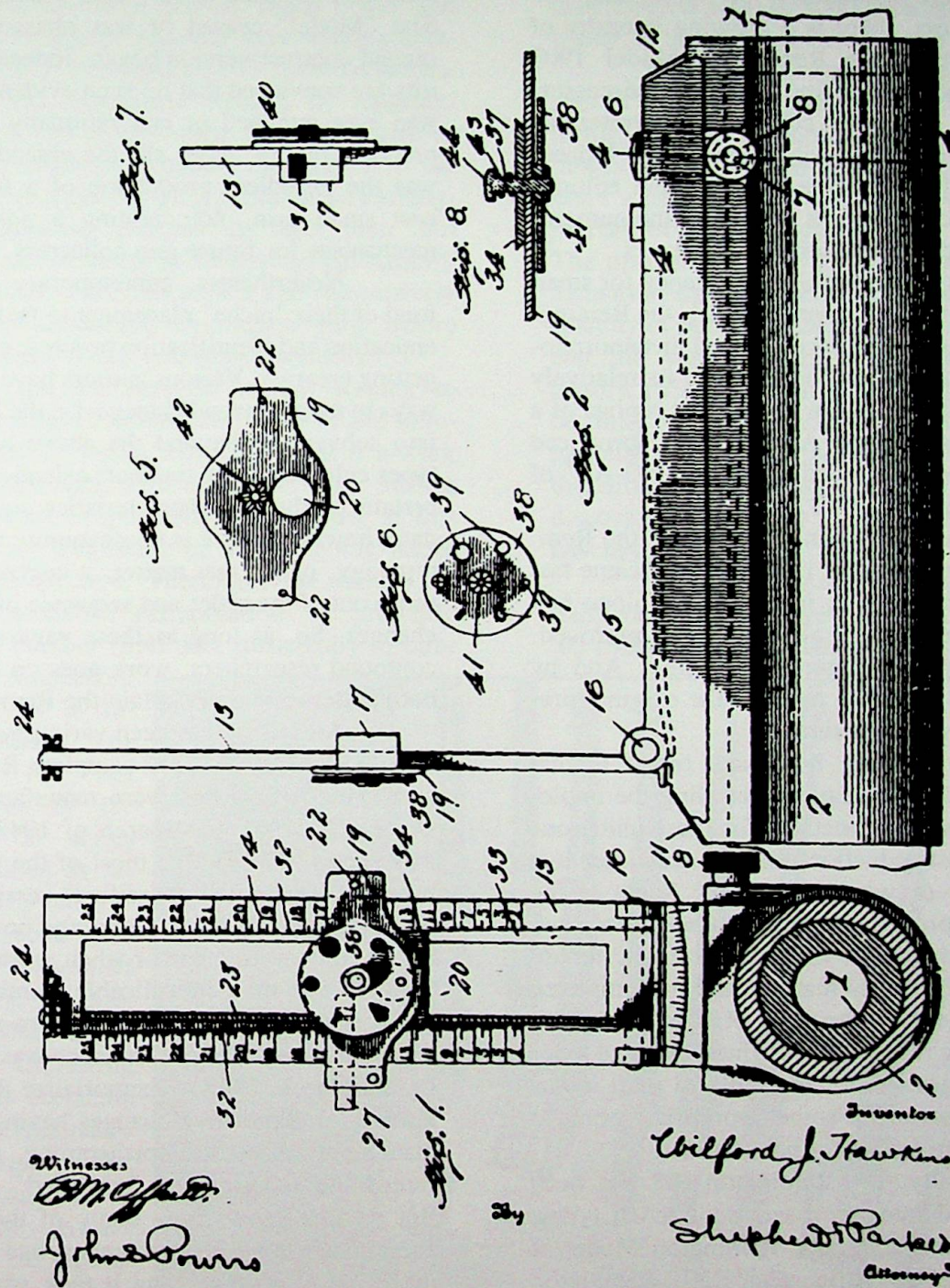

# The "RED STAR" Remington '03 Rifles

**W**ithin the community of Springfield '03 collectors, there is a growing intensity of interest in the Remington Model 1903 pattern. While not as well known as its predecessor, it ranks among the most curious and mysterious because it refuses to be easily stereotyped. Indeed, it is not unusual to examine two different editions just a few production months apart and find numerous anomalies and manufacturing differences.

Born out of a British/U.S. urgency for small arms at the beginning of World War II, the Remington '03 went through an unprecedented metamorphosis of tolerance and design changes over its relatively short life. Literally, it began as an exact replica of a 1919 vintage Rock Island Arsenal (RIA) produced Model 1903 rifle and ended up as the "03-A3" of WW II fame in just over 15 months.

After the production inaugural of the Remington '03 in September of 1941, changes came fast and furious. For example, in November alone 649 tolerance changes<sup>(1)</sup> had already been approved, mostly for component interchangeability. And by December, 1942, only 23 parts of the original pre-WW II RIA '03 still remained<sup>(2)</sup>.

The problem frustrating historians today is that reliable factory documentation recording the implementation process and timetable for these numerous tolerance and cost reduction changes are either lost and unavailable, or were never kept. Some of the changes were approved informally, others by written directive from the Chief of Ordnance; but reconciling when they actually materialized on completed rifles has challenged fanciers of this intriguing variant for a long time. Many of these oral and letter authorized changes simply accumulated until it was decided by the parties at some appropriate point to memorialize them into a formal contract.

Historically, the Remington '03 has been officially divided into two basic contractual types, i.e. the "US Rifle, Cal. .30, Remington Model of 1903" and the "U5 Rifle, Cal. .30, Remington Model of 1903 (Modified)." But, here again, making a distinction between them gets very confusing as

related to any kind of definitive breakpoint when the first "Model" ceased or was phased out, and the second contract version began. Indeed, some collectors are convinced that no such evidential distinction was ever intended or can rationally be made as a practical reality. After all, the objective at the time was the expedient production of a functional, low cost small arm, not creating a positive tracking mechanism for future gun collectors.

Nevertheless, contemporary collectors are fond of their "niche" placement to facilitate the authentication and identification process, even if it means getting creative. Various authors have tried differing ways to more narrowly categorize the Remington '03 into subvariants beyond the above two contractual types either by serial number, calendar period, or by certain production characteristics and features. To date, however, there is no unanimity regarding such typology; or for that matter, a cogent way to make sense out of the order and sequence of the numerous changes. So, as long as these vagaries continue to confound researchers, work goes on in the quest to both understand and explain the Remington '03.

All told, it has been variously estimated that from 350,000 - 365,000 complete Remington '03s and "Modified" rifles were manufactured between October of 1941 and March of 1943. Evidence to date seems to show that most of the guns produced were of the so-called "Modified" version, but no one really knows with any certainty how many completed rifles were made or when production actually began due to their inexplicable identity. It's known that a formal contract revision between Remington Arms and the Chief of Ordnance was consummated in mid-March, 1942 to memorialize the fact that the number of cumulative changes having already been made, plus those still forthcoming, officially warranted the redesignated "modified" nomenclature. But no one knows how many of the earlier rifles containing "modified" changes had already been made, let alone how long it took after that date to use up all the pre-existing parts inventory that would further obfuscate identification right to the end.



Also, as related to the very first rifles produced by Remington, it is likewise unknown when the actual Remington '03 replica of the RIA "clone" absolutely ceased manufacture and the altered versions leading up the so-called "modified" first began to show up. For example, it is known that changes in tolerance control, metal finish, and certain safety related corrections were verbally authorized as early as November 1941 upon an inspection visit to the Remington Armory by representatives of the Chief of Ordnance. But it may also be true from the evidence available that certain of the safety related changes not incorporated into Remington's manufacturing process up until then, but adopted as a new standard at the Springfield Armory 5 years previous, were called back and retroactively performed on completed Remington guns before final acceptance into the ordnance inventory.

It is not the purpose of this writing to conclude any kind of exhaustive study of the Remington '03 and '03 (modified) guns. That is a work in progress with much remaining to be done. Suffice it to say that some speculation is in order at this point to put the magnitude of the foregoing issues into better perspective. Therefore, the author has attempted reasonable extrapolation of presently known serial number (SN) data sufficiently to infer intelligent discussion. To that end, it is suggested that approximately the last 300,000 rifles of the Remington '03 series can be described as far more internally consistent in character and features with each other than the first 65,000, even though the changes continued, including stamped parts replacing milled parts. That really means, however, that the first guns made represent the greater challenge to the typologists' objectives. These guns were likely as-

sembled in the first 6 to 8 months of actual production, when perhaps as much as 80% or more of the total changes made in the Remington '03 series had either been proposed and/or actually placed into effect. This was the great transition period. And within this initial production series, perhaps no more than the first 3000 to 5000 guns are uncompromised clones of the original RIA pattern.

What all this really comes down to, which gets us to the primary purpose of this writing, is that further extensive examination is needed within key ranges of extant serial number examples in order to more accurately define or describe the evolutionary journey of the Remington '03.

The problem to date making comprehensive documentation difficult has been a combination of both scarcity of published data about rifle variation detail, and the wide dispersion of ownership of these historic rifles. This difficulty will likely never finally be fully resolved short of a far more complete national inventory. However, a very positive step in that direction has recently occurred with the growing discovery of the RED STAR rifles!

#### **Discussion:**

The following study-analysis reveals potentially more than 120 previously unknown Remington '03 rifles that have become extant relatively recently





and are slowly making their way into the collector market. Of that number, 60 have been partially identified by the author, of which 9 are the subject of this writing. These 9 relatively early production Remington '03's have been examined in detail in terms of the visible component identification and manufacturing process characteristics used to traditionally describe and/or distinguish between them (i.e. no guns were dismantled). They are tabulated in a matrix analysis herein and are being referred to as the Red Star rifles for referential convenience. They are also believed to be a significant historical find insofar as an exhaustive follow-up effort could perhaps update previously published Remington '03 data deficiencies, as well as help explain the many anomalies of this important predecessor to the Remington Model '03-A3.

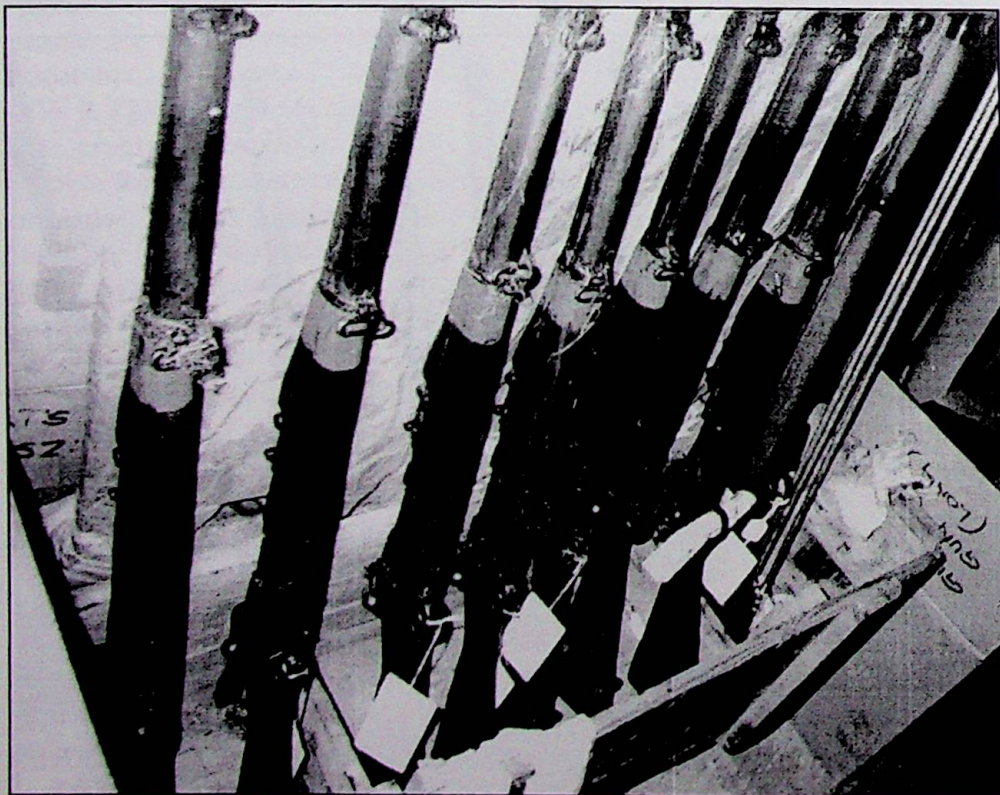
As the Red Star story goes, at least 10 crates of British "Lend-Lease" Remington '03's came back from England in about 1955 and remained essentially unopened for over 40 years! This is noted to be entirely feasible, incidentally, since most of the first 100,000 Remington '03's produced are reported to have been issued as "Lend-Lease" to Britain<sup>(3)</sup>.

These particular guns were purchased privately from the British military, presumably after

being declared surplus. They were then shipped back to the United States by a U.S. Army Air Corps officer who was stationed in England after WW II, and who remained there for the duration of his military career. The guns were shipped approximately 12 to a crate in heavy grease and a straw-like packing material. Of the total, over 5 crates have been placed on retail consignment for sale via the "Red Star Military Museum and Sales" of Culver City, California beginning about 2 years ago. It is unknown how many of the guns have made their way into circulation through the owner's personal efforts.

Ian Shein, a curator for Red Star who was assigned the disposition of these guns, also advises that for personal reasons the owner removed some of the guns from the consignment before delivery to Red Star. Even so, the author has accounted for 60 of them whose serial numbers are tabulated herein. Out of this original consignment, all but 8 have been sold, therefore are unavailable for viewing. However, one previously sold gun has been viewed under a separate arrangement with its new owner. Of the 8 guns still with Red Star at the time of this writing, 3 are pending sale. The unverified 5 or more crates that remain in storage are presumably still in possession of the original owner.

The author personally examined each of the 9 guns on May 7, 8 and 15, 1999. It is noted that essentially no verifiable data is available at this time for the 51 guns already sold, except for the enclosed tabulation of their serial numbers from sales receipts. The condition of the guns vary. Basically, the metal parts are in fine to excellent condition, including the bores, not counting normal bolt turning wear. However, the stocks in some cases are only in fair to very good condition, containing drying splits, handling and shipment dings and abrasions. Indeed, a portion of them appear repaired and/or sanded, although the heavy

grease obscures clear observation in a few instances. The somewhat stark contrast between the condition of the metal and many of the stocks is not completely understood.

Each of the guns has an irregularly painted red band about 2 to 2½ inches wide completely around the stock and forearm just behind the middle swivel band. The numbers "30" or "300" are stencil-painted in black within the red painted band-field on the left side of the stock, which incidentally was very typical on Lend-Lease guns. The paint and markings were intended to distinguish the U.S. caliber .30-06 from the British .303 caliber.

In some instances, the stenciled numbers don't line up across the stock and forearm "join"

line. As speculated by Red Star, some of these guns incurred broken forearms from rough handling and shipment, and had to be replaced with forearms from parts guns by others, thus causing misalignment or a mismatch of the painted numbers. Indeed, the author found some of the forearms with multiple splits, crush marks and splice repairs. All of the guns contain only the original U.S. arsenal inspection and assembly stamps and markings. None of them contain the characteristic British proof or other markings indicating they departed England through formal export channels.

Following are general observations about the Red Star rifles examined, supplementing the key features summarized in the matrix on the next page:





- (1) 3008004 Not original forearm; sub-inspectors stamps & Cartouche OK; Stock OK. Sold or pending sale.
- (2) 3028766 Cartouche lightly stamped; minor stock split behind receiver tang; minor split on top front portion of forearm; sub-inspectors stamps OK; stock otherwise OK.
- (3) 3032088 Original forearm; cartouche OK; sub-inspectors marks OK; stock OK. Sold or pending sale.
- (4) 3037150 Not original forearm, cartouche and crossed cannons sanded off; sub-inspectors marks OK; stock OK, but erratically sanded.
- (5) 3040537 Original forearm; sub-inspectors stamps OK; stock OK. Sold or pending sale.
- (6) 3043366 Not original forearm; sub-inspectors stamps OK; stock OK, but finish weak; cartouche lightly stamped.
- (7) 3045650 Original forearm; sub-inspectors stamps OK; stock OK; minor splits in forearm; cartouche light, but OK. Sold or pending sale.
- (8) 3051158 Not original forearm, and splice repaired; sub-inspectors stamps OK; stock OK; cartouche OK.
- (9) 3053292 Original forearm; minor stock split at rear of receiver tang; forearm slightly cracked; light cartouche, otherwise stock OK.

Note: "Stock OK" means: straight "S" grip; 2 recoil bolts; no handguard ring cut; 7/16 inch diameter circled "P" firing proof & "assembly" stamps present.

### Observations and Findings:

From the matrix analysis and general study of the Red Star rifles, the following findings and observations were made:

(1) The 9 guns actually examined appear to be a fairly representative serial number cross-section of the 60 gun consignment (see Exhibit A, last page). It follows then, that if the 5 or so crates on Red Star consignment are representative of the entire original shipment, these 9 guns may well be indicative of all the guns in the lot.

(2) The predominant serial number range of the Red Star consignment varies from approximately 30,000-50,000, which appears to fill a substantial data gap absent in most of the existing reference books on the Remington '03's. The question is posed then: could this absence be reasonably explained by many of the early serial numbers having been shipped to U.S. allies as Lend-Lease guns, thus a significant representative example not being in circulation on U.S. soil?

(3) Only the earliest dated gun with the lowest SN contained a finger groove stock.

(4) Only two of the 9 guns contained the rear sight base lightening cuts, both amongst the lower serial numbers.

(5) Of the 9 guns, 5 contained a NON-"drilled-thru" receiver tang for the rear stock bolt. It is interesting to note that within this sampling range, there is a tendency for the higher serial numbers to just as likely have the original Springfield tang configuration, i.e. SN 3028766 was drilled through, but SN 3053292 was not. This could well be illustrative of the inverse logic practice by the Armory of "first in - last out" for some duration of parts on hand.

(6) All of the bolts except the very earliest serial number contained the later edition large gas



port hole, but also had the early version gas port hole in the extractor end. Only the lowest serial numbered gun had the *small* gas port in the bolt body.

(7) The earlier the serial number on the gun, the less likely it appears that one will find a punch mark proof on either the right side receiver "ledge" or within the end-of-barrel ordnance bomb. For example, the serial numbers before approximately 35,000 contained neither proof mark, but all of the numbers over approximately 50,000 had both punch mark proofs. The serial numbers in between were unpredictably mixed.

(8) All of the safeties contained the script lettering style, with no hole in its edge.

(9) All of the small metal sub-parts, i.e. bands, trigger guard assembly, swivels, follower, etc. were milled parts consistent with the RIA originals.

(10) All of the guns had a gas port on both sides of the receiver, including the earliest one. It is unknown how many, if any, of the gas ports on the left side were retroactively drilled after the gun was completed.

(11) All of the guns were cartouched with an "RLB" in a box

(12) At around SN 40,000, the "Bolt Stop" in the receiver seems to begin its disappearance. While the receiver may have been drilled for it, the pin was not necessarily present. Then after about SN 50,000, both the bolt stop and its pin disappeared altogether, including the two "indents" on the face of the mating bolt lug.

While not identified as a formal distinguishing parameter in the matrix for purposes of this study of the early Remington '03s, the following characteristics were also noted to be uniformly present on all 9 rifles:

(13) All of the guns contained the original Springfield milled features in the area of the cut-off seat as well as fore and aft of the cut-off spindle housing, including the run-way groove for the cut-off plunger.

(14) All of the guns contained the original rounded Springfield receiver bridge at the rear area.

(15) All of the guns contained the "flat faced" version of the rear sight windage knobs.

(16) All of the guns contained the "square"

shaped sear opening in the receiver, and without a hole drilled thru the center-bottom of the receiver in front of the sear opening.

### Conclusions:

In closing, it appears this batch of Remington '03 guns tend to bear out many reports that the primary rifle components for the original start of production were "on hand" in variable quantities prior to start of assembly. Also, it appears that the specific features of each rifle are far less influenced by serial number or barrel date sequence in many instances, than by the staging-sequencing lineage of the manufacturing and assembly process, including "first in—last out". The illogical lack of a gradual predictable change in the character of the finished product cannot be accounted for any other way, particularly within certain serial number ranges. It is postulated that this historical confusion can only be explained by the integrated affects of: (1) the various sequential steps in the manufacturing and assembly process involving handling the same parts at different times in the production sequence, along with; (2) the variable and inconsistent volume of various component parts available "on hand" preceding actual assembly; (3) the non-inventory control practice and procedure of "first in—last out" parts assembly; and (4) the frequent changes progressively interspersed over time regarding production finish, design simplification, and tolerance relaxation intended to facilitate cost reduction and increase the rate of production.

In my opinion, the number of rifles actually produced that can be considered a pure RIA pattern gun is far less than previously guesstimated over the years, perhaps numbering under 3000, with the last serial number doubtfully exceeding 5,000 or so. There were none in this group of rifles examined. Also, until the Remington '03 "Modified" production became more or less stabilized after about mid-1942, employing most of the eased tolerance and cost reduction changes imposed by the Chief of Ordnance, an evolving landslide of transition changes in the 6 month period between December, 1941 and May, 1942 occurred that simply defy any predictability from a simple examination of their serial numbers and/or barrel dates alone. Perhaps these mixed attribute or multi-characteristic guns can



never be feasibly subclassified further due to being in an almost constant state of transition. Even so, there are strong indications that a pattern of some kind is emerging within certain characteristic areas of the manufacturing and assembly changes that can be correlated to serial number range predictability. The punch mark proofs on the right side receiver ledge and within the barrel ordnance bomb, along with cessation of the bolt stop in the receiver, are such examples.

The Red Star rifles have provided much needed physical evidence in filling a critical knowledge and data gap, but much more work is inevitable to tell the whole story.
