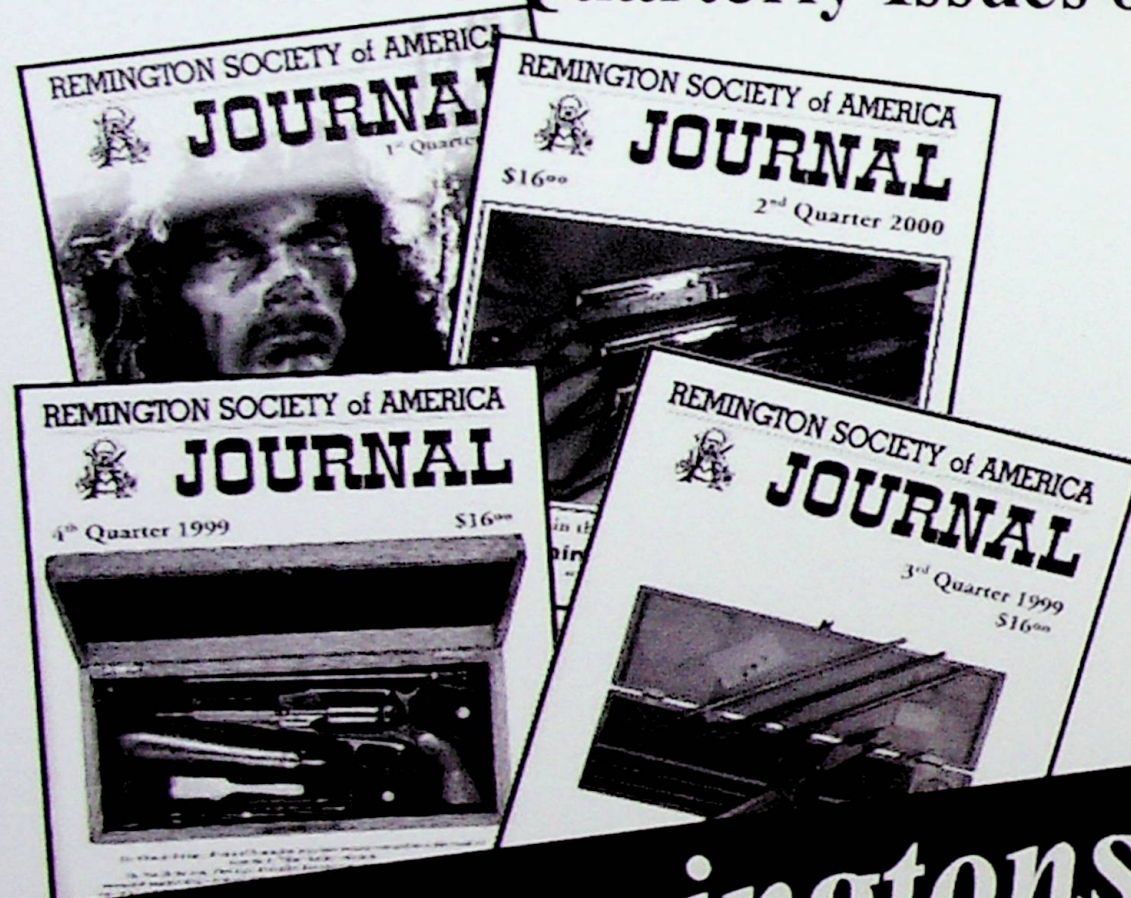

## MISCELLANEOUS NOTES

There have been many changes at recent gun shows throughout most areas in the U.S. The sale of modern pistols, military type rifles, and ammunition has skyrocketed. In many cases manufacturers and companies dealing in rifles, pistols, and major components are back ordered and cannot deliver without long waits. Retail shops seem to be able to sell all that they can acquire and are waiting to fill customer orders. This appears to be true of reloading components as well as many accessories. The prices are escalating for these products and manufacturers are at their capacities. Many types of ammunition are selling for several times the price that was charged last year. It is not uncommon to see pistol ammunition at \$ 20 per box and rifle ammunition at \$ .50 per round. It would take a very lengthy discussion to determine the exact cause and rationale but there is a wide spread desire to buy both the weapons and ammunition.

At the other end of the spectrum there is the antique trade. Many antique dealers say that show sales are down except for the really fine quality at high prices.

There appears to be sparse inventories of fine antiques at many gun shows.

A brief review of high end auction results appear to have sales of fine weapons selling at a slightly lower price than a year ago. It seems that there are some very fine weapons being sold at comparative lower prices.

It is a good market for those that have the funds to take advantage of this latest trend. We will need to look at the markets over the next year with some general Washington issues that include a projected commercial real estate, the high end residential market, and the next phase of the credit card business. There are many economists projecting a longer adjustment

period for housing and unemployment rates. This will obviously affect the gun market.

### *Current interests*

SRS receives many requests and inquiries for data on trapdoor 45/70 rifles and carbines. I am happy to say that there have been many new finds of Indian War era carbines and rifles. It is a continual environment where rare and very collectable weapons are being uncovered. Many people see weapons being brought into gun shops and to gun shows to seek information, and find a source to get rid of an old gun. There is a minimum amount of information available to the average person. One finds a weapon and has no interest and usually wants to get rid of it for a variety of reasons. The result runs from asking questions concerning its worth or just simply wanting to sell it for what is offered. The result is that most dealers do not have any information on the history according to the serial number. Often it is mis described unless the dealer talks to others and finds data in a reference book. Many rare guns have not been accurately researched. In general terms, most serial numbers are never researched.

Unfortunately unknowing sellers do not get a value that is appropriate and many buyers do not value most guns at their real value.

A weapon that is found in an attic or a family item that has been handed down is on a journey of unknown time until someone researches the item. The other extreme is the common weapon that is offered as a rare collectors item with a high price or a weapon that has been altered, refinished or has new or false parts. This occurs both intentionally or unintentionally.

Unfortunately anything can happen and there are no real common standards. We find guns at gun shows that are described as issued to a very interesting

military unit with inaccurate or false SRS information. The most common statement is that it is numerically near another verified serial number and that makes it a verified SRS documented gun. This is false information and any buyer should be wary and never buy a weapon on hearsay or questionable information. All SRS letters have specific data that is unique to the specific number which is based on a U.S. Government document. There were three different signatures for all SRS letters over all of the years of operation. Anything that is in addition to the three unique signatures or any data that is not signed is very questionable.

### ***Serial Number Oddities***

It is still difficult to easily explain that most military weapons are not in serial number sequence nor in an exact production schedule. Springfield Armory did not have a conventional production line. The identical model of a weapon could be assembled at ten or more locations by different personnel with parts chosen at random from existing supplies. Using the Krag rifle as an example, there were as many as 15,000 receivers in the supply system at one time. Any one receiver could be assembled alongside another receiver by the same technician at the same assembly location. Both with completely different serial numbers that were hundreds or thousands of numbers apart. Shipment checking of sample crates of ten resulted in no consecutive weapon numbers found in the same crate.

This test and survey was done because of a Congressional inquiry concerning data on numbers of weapons manufactured with a royalty paid.

A verified serial number may increase the value of a weapon anywhere from a small premium to a great deal of money. The most sought after weapons are Custer carbines and revolvers, and weapons used

at San Juan Hill during the Spanish American War. There are many others such as experimental item, weapons issued to senior military and political personnel and those issued in famous battles. Many unique items include weapons used by the USMC, OSS, sniper rifles from all wars, and all items from historic United States operations. A record must exist from United States documents that specify the exact serial number. We are fortunate to have found a large amount of data that has serial numbers, sale of the item to an individual, and the Springfield Armory description of the specific weapon. Other data may only have the military unit and date. It is however, very sought after by military collectors.

### ***Springfield Research Letters***

We are continually writing letters for our subscribers. Our back up has slowed to a certain extent but we are always searching for the needed data to write a complete letter. Many times, the Archives can not locate a source document that we previously checked out. This causes major problems and if there is no back up, the data may be lost forever. The recent somewhat amusing occurrence at the Archives is in the area of rules of research. I recently arrived at one of the buildings with a government issued and dated photo ID card. I required another badge issued as a temporary visitor badge. I proceeded through several areas of inspection and proceeded to research several original Civil War books. My standard uniform is a blue blazer with khaki pants and loafers. When I took my blazer off and put it on the back of my library chair, a government security type rushed over to me and instructed me to put my jacket back on immediately. It was OK to have a soiled T shirt or sandals and cutoffs but I must wear my jacket or not have it with me.

This was before leaving when I was checked, all papers including personal papers brought in with me were checked and looked over by guards at two different positions. They excel at their jobs.

#### **Recent Activity**

Our web site has had a continual activity of one thousand to fifteen hundred hits per month.

SRS will provide the following letters for 2009.

**Basic letter-** This letter provides information from the SRS data base that was compiled over many years of research. This letter will include information on a weapon and its use such as military unit, date, and possible secondary information. It will not include specific data on names or combat use that requires travel and research through extensive visits at government facilities. This category will include **Sales letter information** with any available sales documents and other similar data. We receive many requests for 1903 sales rifles, NRA sporters, National Match rifles, International rifles, Colt, Smith & Wesson pistols, and General Officers weapons. We will provide Springfield records of DCM sales documents if available.

**Research letter** -This letter requires travel to government facilities and research government. It takes a minimum of one day of analysis and requires travel, research, and review at government facilities. These efforts will be limited in number and may take several months to accomplish. Competition of the search is based on time and availability to visit the government facilities as well as their regulations.

Additional data will be listed on our web as it becomes available.

#### **Springfield Research Service Data Base**

Website access to the serial number data base was shut down. This was necessary due to many misuses of the data. We are now in the process of developing a new on line service. We will be working on this over the next year. There are still dealers using SRS data as a sales thrust saying that a weapon is close to a known number and therefore this rifle belongs to the same military unit. This is bad information and is not accurate. Misleading information can be made and it is not authorized by SRS. All SRS data is copyrighted and no authorization has been given for its use. Our subscribers to the US Martial Arms Collector Magazine and Springfield Research Newsletter deserve the benefits of SRS and may email a request for a serial number at any time. We will respond with a yes or no that we have data on that specific number. There is no charge for subscribers. We are doing research on starting up another on line serial number capability. This will take an extended amount of time and the results will be printed and on our web site. Mail requires extra time for an answer to a number request. ## Remington Model 51

The model 51 was manufacture red by Remington Arms Company and marked Remington Arms-Union Metallic Cartridge Co. Inc. Remington Ilion Wks. Ilion N.Y. U.S.A. Pedersen's Patent Pending. Production ran from 1918 to 1934 in calibers 32 ACP and 380 ACP. This civilian pistol had a limited production of 65,000 pistols made prior to World War 2. Requirements for special pistols during the war were filled by United States Government contracts to buy existing stocks of commercial arms. The small amount of pistols purchased has brought out a group of weapons that are in great demand by collectors.

The Model 51 had the ability to be easily carried and concealed. It had a seven round detachable magazine with a single stack configuration. The pistol had a blued finish with a three and one quarter inch barrel and weighed twenty one ounces. Part of its unique design is that no screws were used in construction including the grips..

All pistols noted below were made in caliber 380 ACP for the Office of Special Services (OSS) during the war. We have found serial numbers for a small number of these pistols. A collector would be very fortunate to find one with its unique usage by the OSS.

Remington tested a heavier Model 53 in caliber 45 ACP prior to World War 2 but did not complete production or manufacture. Production of the Model 51 was terminated before World War 2 but the United States Government bought these weapons for critical operations. All were chambered for the 380 ACP caliber.

In addition to Remington, handguns were bought from Harrington & Richardson, High Standard, and Orgies. They included weapons of various types and calibers.

There were more significant numbers bought from Colt and Smith & Wesson. The war effort and demand for arming, training and selected operations looked at all possible sources of weapons and support equipment. It is probable that many items were used in historic situations throughout the world. It is hard to find and verify their origins and operations. Our search continues.

We look at future article information and many sources indicate other items that were used for special operations. We welcome any comments and factual information on

the use of rifles, handguns, and special weapons used in international conflicts.

#### ***Editors notes***

We have found data on several other handguns and additional data on standard military weapons used by the OSS and other operations at embassies around the world. We know of Krag carbines used by the Marine guards in the 1930's and Winchester 6mm Lee rifles in use from the Spanish American war through 1925. Lee rifles were also used as guard guns for U.S. Presidents and other personnel. The use of Colt caliber 25ACP, 380 ACP, and 32 ACP have been found as General officer issues as well as other uses. The use of Smith & Wesson Lightweight revolvers were made for the USAF and the Army Air Corps.

It appears that there are quite a few weapons used in addition to standard military firearms. Comments are sought on any weapons that were used by the U.S. Forces.

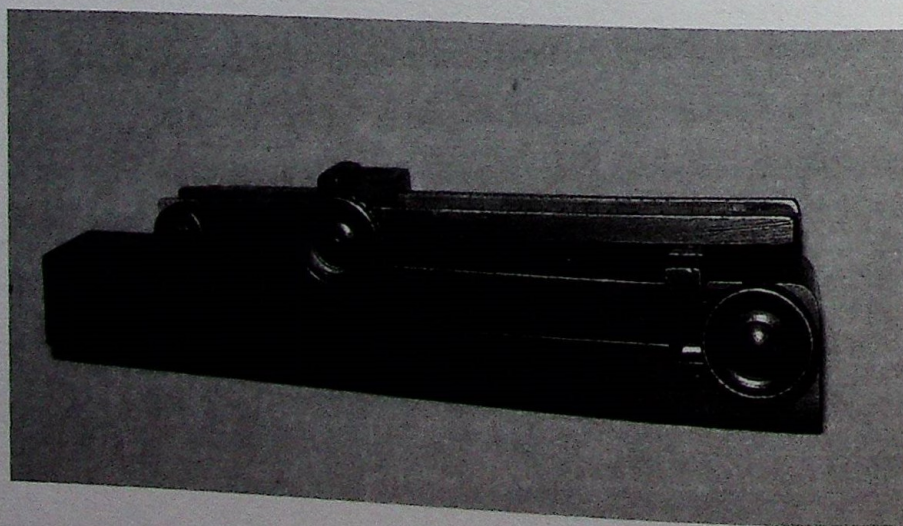
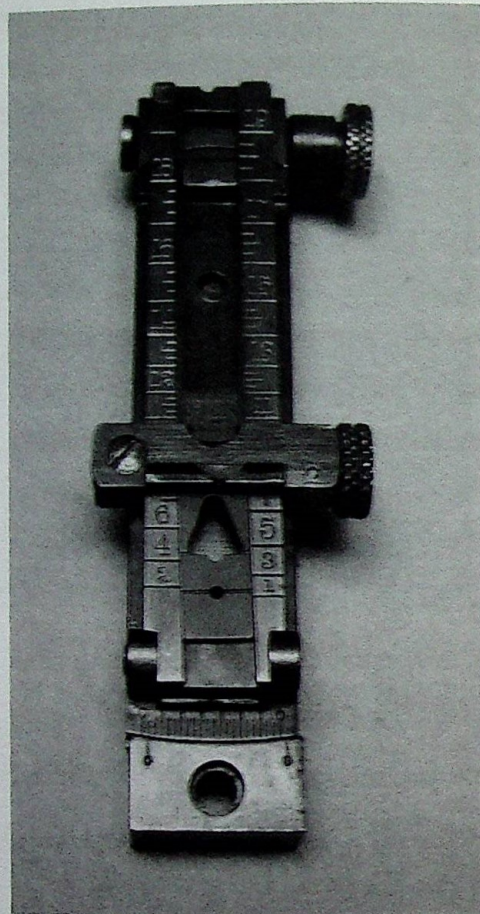

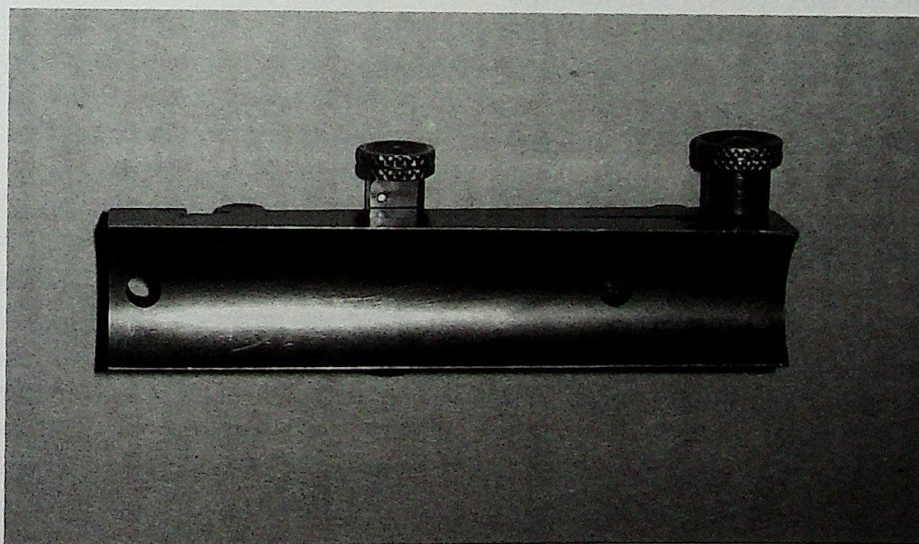
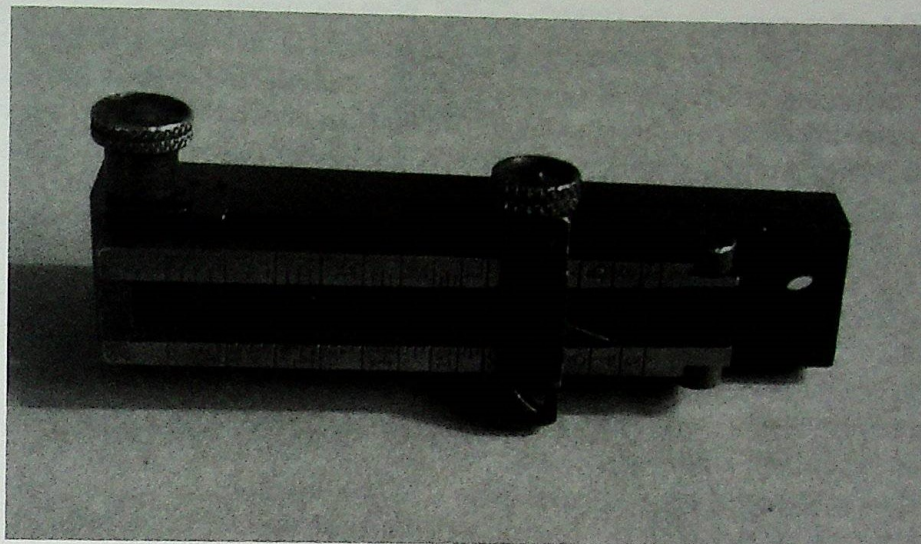
## The Model 1905 Krag Rifle Sight

The Krag rifle and carbine remained in service long after the 1903 Springfield rifle was introduced and used by the U. S. military. The Krag rifle stayed as the standard for the U.S. Navy almost two decades after the 1903 was produced for the U.S. Army. The 1905 Krag rifle sight was authorized and produced in very small quantities by the Springfield Armory. Col. Frank Phipps signed off on the drawings on June 14, 1906. The sight was designated "Rear Sight, Model of 1905, U.S. Magazine Rifle, Model of 1898". The fixed base was 3.3786 inches in length and was fitted to the Krag barrel using the same type of screws with the same spacing as used for the other Krag rear sights.

No alterations were made to the barrel. The fixed base was new and machined to match the barrel contour with similar machining as the 1903 2400 yard rear sight. The leaf assembly was graduated to 2000.







The rifle required a new front sight and hand guard to work with the rear sight. The front sight used the same fixed base with a dovetail modification and a moveable sight and blade secured by a screw holding the moveable stud in place. It was drilled and taped in the front of the fixed base.

The hand guard was altered to accommodate the bigger rear sight. At least two weapons have been found and the total small number manufactured is unknown. *Sight courtesy of Doug Rainbow. Data and photos from SRS files.*

## **U.S. Marines NRA Sporter Rifles**

The 400 NRA rifles owned by the USMC during World War 2 has been an illusive weapon for collectors. There is no doubt that they existed but there have been no documentation found to show their disposition, use, or final configuration. The Justice Department owned the weapons before the war and sold them to the USMC. There were 300 rifles in serviceable condition and 100 with bad barrels. Other observations of odd 1903 barrels include a 1942 dated series of barrels made as a replacement. They have a slightly different contour and no evidence of any rear sight or rear sight base. There have been observations of NRA sporters with this type of barrel but no documentation to date. The barrels observed had a blued finish and 1942 is the only date that has been seen so far. The underneath of the barrel has quite a few markings including steel lot numbers, steel markings believed to be the company providing the blanks, and star gage markings. Other marks may be the drawing numbers. It is possible that the barrels were made as replacements for the 100 rifles with bad barrels that were sold to the USMC. No data has been found to confirm this. The FBI Institute was located at Quantico Marine Base in Virginia and Justice Department personnel and other agency personnel are still being trained at Quantico today. It is believed that the items were to be purchased with several options for their use. They included: use as spare parts, restocked and made into service rifles, and held for training or other operations. In March of 1942 discussions were held and a transfer of the weapons was made without transportation to another location. We have not found documents on exact work done or issue to USMC personnel. The attached documents are part of the research that has

been uncovered. The USMC personnel involved include Major Van Orden, the well known USMC sniper developer, and manufacturer of Van Orden rifles for the USMC. His activities also include the sought after Winchester series of sniper rifles. Major Blanchard and Colonel Waller as well as the Commandant of the USMC and the director of the FBI are all listed in the correspondence.

The search for an original rifle in its original form and finish and any rifle that has been modified by the USMC is on and may lead to a very nice find. It has been a conversation for years over the status of NRA Sporters with modifications that are unknown. This includes different barrels, sights, and other work. No observations have been noted of parkerized weapons or service rifles with drilled and tapped receivers that are known to be original to the gun. Examples of 1903 target rifles with star gaged barrels have been found in service condition with WW2 cartouches. There is no doubt that the war effort was underway and the USMC would have used all resources to have more weapons. Unfortunately, almost anything could have happened after the war as far as disposition, modifications, and later civilian use and modification.

Some fortunate collector is going to find one of these rifles and be confronted with trying to verify its history, or unknowingly use it, shoot it, or keep in his collection as it was acquired.

All of us now have another target to look for in the search for U.S. Military rifles.

Subject matter: Major George O. Van Orden called from Quantico and reported the fact that he had received information from Mr. Glavin, Assistant Director of the FBI School, Quantico, that the FBI was discontinuing the use of .30 cal.

They have at Quantico, 400 Springfield Rifles with sporting stocks, of which 300 are in excellent condition and approximately 100 need rebarreling. He further stated that the FBI has at the FBI Institute, Quantico, 300,000 of caliber .30 M2 ammunition and probably 40,000 rounds in the field that they desire to dispose of and would be glad to sell it to the Marine Corps.

The 400 Sporting Springfields could be used for spare parts, if for nothing else, or restocked into service rifles

This office has received information that the use of caliber .30 rifles is to be discontinued by the FBI, and that there are on hand at the FBI Institute, Quantico, Va., 400 Springfield rifles with sporting stocks, 300 of which are in excellent condition and approximately 100 in need of rebarreling. It has also been learned that the FBI Institute has 300,000 caliber .30 MC cartridges at Quantico, and approximately 40,000 in the field.

The Marine Corps would like to purchase the rifles and ammunition, and in the event the sale meets with your approval, it is requested that this office be informed of the cost, in order that funds may be set up and a formal order placed with your Bureau.

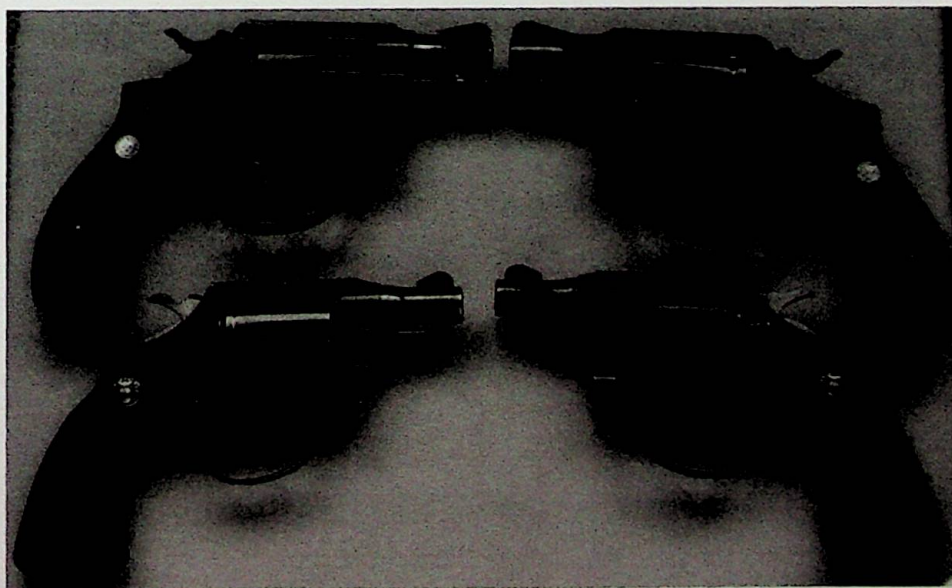
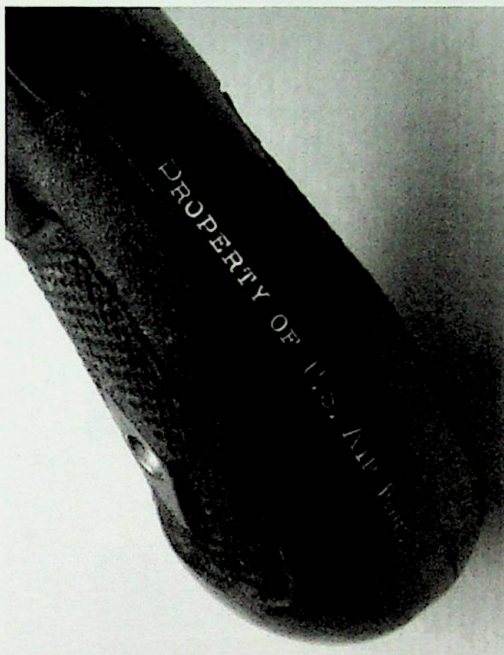

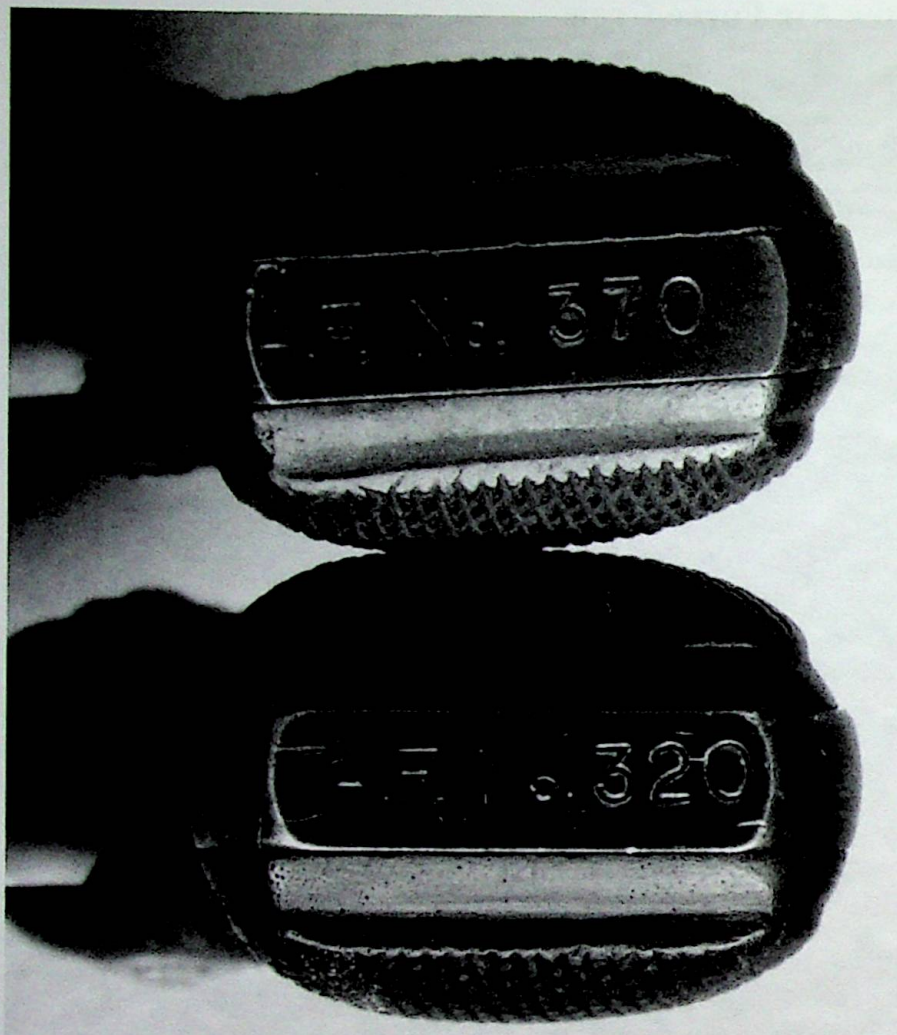

WELDING OF M-14 NATIONAL MATCH RECEIVER FR-560477		

1. Scope: This specification covers the preparation, assembly, preheat, weld and inspection of the M-14 national match receiver.
- 1.1 Records: Records shall be kept of welding, serial numbers, welder's symbol, date of weld and other pertinent information on welding and inspection.
2. Detail Requirements:
  - 2.1 Part Preparation and Assembly: The selector shaft lock, FR 560335; selector shaft, FR 560275; sear release, FR 560490; and pin FR-481-02 are to be supplied to the assembly location free of protective finish. If grit blasting is used to remove the protective finish, precautions must be taken to remove all grit before assembly. Receivers are to be supplied in the hardened and tempered condition and the sear release lug area is to be cleaned by blasting. Parts are to be clean and dry before assembly and they are to be assembled in the semi automatic position.
3. Process: Welding shall be performed by the gas, tungsten arc welding process using 1/16" dia. 2% thoriated tungsten electrode.
4. Filler Wire: The filler wire shall be .020" diameter and conform to AMS 5679.
5. Welding Equipment:
  - 5.1 The machine source of current shall have good regulation in the area of current required.
  - 5.2 Current shall be direct using straight polarity at 40-50 amps.
  - 5.3 Argon flow to be 10 cfh.
  - 5.4 Electrode Cup No. 5.
6. All accessory equipment including holders, leads, ground connections, work handling equipment, etc., shall be kept in good repair and maintained within acceptable safety standards.
- 6.1 Fixture: Bench universal joint fixture with barrel chamber section welded to rod is to be used to hold the receiver in position for welding.
7. Qualification of Welders: Welders to qualify by welding a mock up of the receiver, selector and sear release assembly which must be acceptable to the magnetic particle inspection, visual standards and dimensional inspection standards set up for the assembly.

## 8. Welding Technique:

- 8.1 Preheat: Torch or furnace preheat assembly to 400°F. If a torch is used for preheat use a contact pyrometer to check temperature.
- 8.2 Welding: Ordnance blueprint number 560477 contains sketches showing areas of welding and size of welds required. Sequence of welding is as follows:
- A. Selector in semi automatic position; sear release forward against sear release lug of receiver; selector lock pushed in for minimum clearance with sear release.
  - B. Tack weld flange on selector shaft to sear release at bottom corner. Complete weld as shown in view C of 560477.
  - C. Tack weld sear release to forward portion of receiver sear release lug. Complete weld on inside and bottom of receiver lug and sear release. Weld outside of receiver lug and sear release. Reference drawing 560477, view B and note 5.
  - D. Weld sear release to rear section of receiver sear release lug. See drawing 560477 view A.
  - E. Plug weld selector shaft to selector lock. Plug weld pin - 2 places - on periphery of selector lock. Reference drawing 560477 section B-B.
  - F. Wire brush all welds.
- 8.3 Fillet welding to be accomplished by complete and even fusion of components into an immovable mass with a minimum amount of undercut. Plug welds are to be smooth with the surface of the selector lock to .020" above the surface per requirements of drawing 560477, section B-B. Plug welds may be ground to size requirements after welding.

## 9. Inspection:

- 9.1 Preparation: Weld area must be cleaned locally by blasting prior to visual and magnetic particle inspection.
- 9.2 Visual Inspection: Visual inspection to be made of welds for fillet size, fusion, undercut, porosity, inclusions, or other injurious defects.
- 9.3 Magnetic Particle Inspection: Inspect weld area by magnetic particle inspection for presence of cracks. Hold all assemblies showing cracks for Materials Engineering disposition.
- 9.4 Dimensional inspection of assembly to be made for conformance to applicable gages.

- 10.2 Plug welds shall be coated per note 8 of drawing 560477.

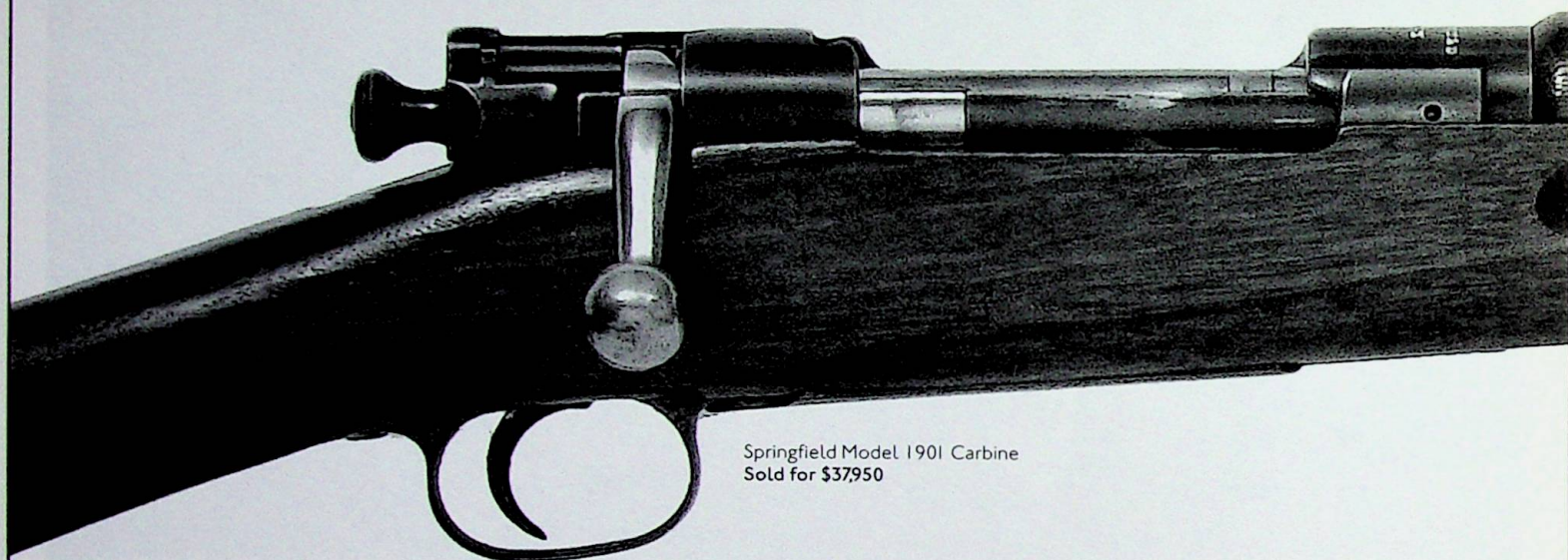

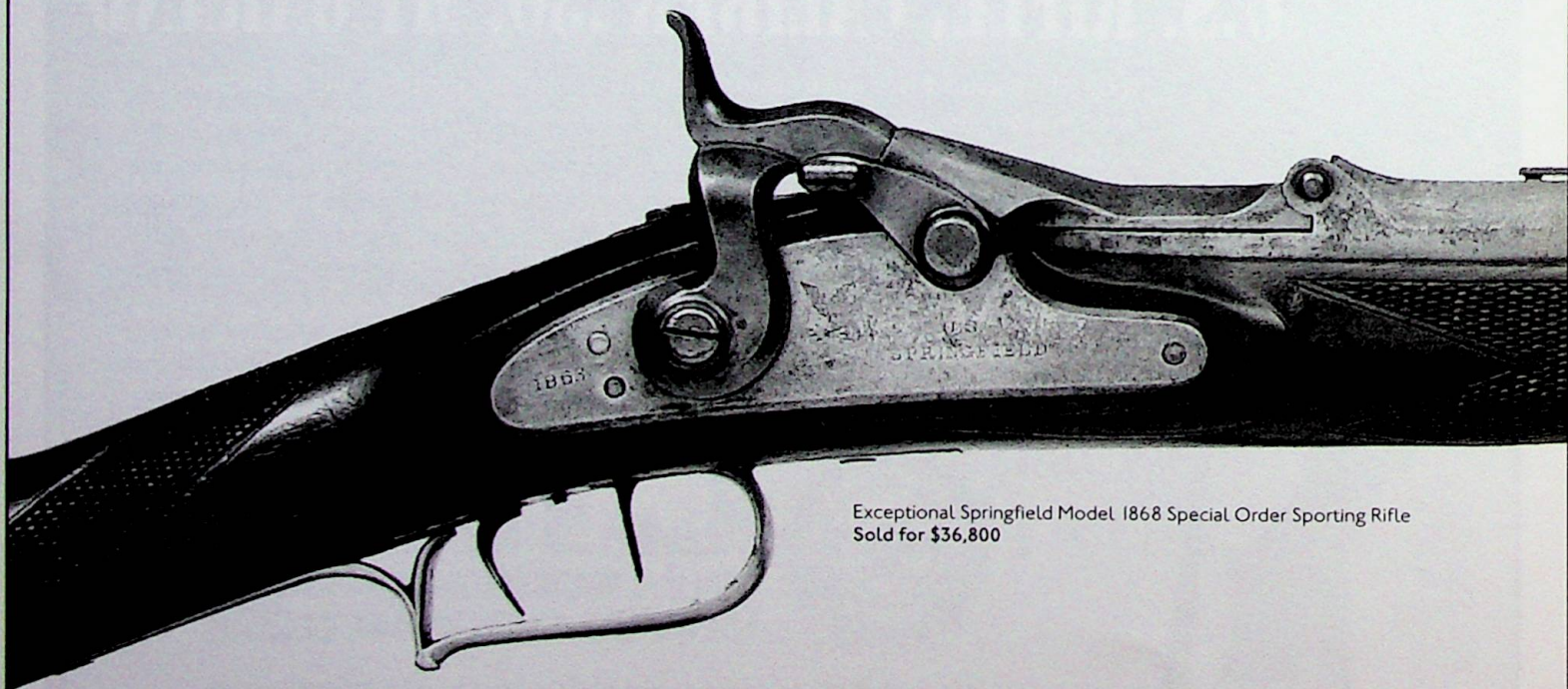
