MARKET FOR WEAPONS AND COLLECTIONS

Many of the key auction houses are maintaining brisk and high- volume sales. They all expect this trend to continue.

The auction houses are displaying at many large gun- shows and accepting items of all makes and manufactures at the shows.

Auction houses provide licenses, contracts, and sales data. They are acquiring all variations of weapons from handguns, long arms, antique, modern, and collectables. Most of the auction companies will pick up high- and low-priced items or discuss with a collector wanting to dispose of a collection. Companies now feature live auctions; internet auctions and internet customers and a wider variety of buyers get a wider coverage across states and countries. There are more customers that can buy an item from their home with delivery available.

The issues of Covid-19 and changing views from U.S. Government officials are still unknown. This includes government agencies that may maintain records that may not be specified at this time.

SPRINGFIELD RESEARCH SERVICE DATA BASE STATUS

The Covid-19 Virus has specified the research that can be done at government facilities. SRS cannot travel and visit the United States Archives. All buildings are closed because of Covid-19 Virus regulations. We have not received exact dates of government openings.

Springfield Research Service (SRS) started

as a newsletter and progressed to a magazine. We continue to write letters based on serial number searches for our subscribers as time and travel permits. There is always a delay when US Martial Arms Collector Magazine is working on deadlines and publication.

We rely on the U.S. Postal Office for all our products. There are some delays that we cannot control. We continue our effort to provide documentation letters but can only provide limited detailed letters. Standard letters and sales letters have a short delay but can be ordered. All letters are based on records that we have after a serial number search.

We will continue serial number searches for our subscribers. The best way to request a serial number search is by email, (editor@usmartialarmscollector.com). Requests by cell phone usually have a 90% chance of being lost or not delivered.

Searches will include data that is available from sales documents and basic letters will have information on unit histories and dates. Complete detailed letters may not be available if the data required is needed from the U.S. Archives. All serial numbers reside in SRS data base and are not affected by Covid-19 restrictions.

The magazine will continue publication on March, June, September, and December of each year. We expect first class U.S. mail to be started on the first of each of the months listed.

We are trying to make sure our subscribers receive each issue in a timely manner. We use First Class US Postal Office mailing for U.S. and foreign addresses. We are always plagued by address changes, no-forward address notices, non-deliverable address notices, and foreign addresses that do not match U.S. formats.

Many of our readers use PAYPAL that includes an agreement between a subscriber and PAYPAL. If an incorrect box is checked with PAYPAL, there may be information not wanted by a subscriber. We rely on PAYPAL notices for payment and addresses.

We reserve extra copies of each printed issue but cannot keep an unknown number needed for reserves. Lately, SRS ran out of many recent issues. We rely on our current mailing lists for our subscribers. Please send any changes to SRS Box 126 Cabin John, MD 20818. We always need updated names and addresses.

SRS will continue to show last issue numbers after each subscriber name. This will be reviewed to use the best way to keep subscriptions up to date.

Direct email to editor@usmartialarmscollector.com is the only way to make sure that a message or photo is received.

We cannot receive all messages from cell phones. We are fortunate to be able to provide Springfield sales letters and basic letters on many serial numbers attached to military units and battles. This includes major

efforts in the past to examine weapon developments and histories. We expect to have more capability to provide research and review of existing information in our loose-leaf files.

CURRENT ISSUE

Issue 169 dated December 2021 is the current issue and set to be mailed the 1st of December 2021.

We receive daily emails for serial number lookups and answer all as soon as possible. It appears that our deliverables have been made except for detailed letters that require travel to government facilities for data confirmation.

Please email if you have not received a document that was ordered.

ADVERTISING

Our full- page advertising deadlines are usually the Friday three weeks before the date of a publication. The projected dates for magazine mailing are the first week of March, June, September, and December of each year. There are four quarterly issues each year.

SPRINGFIELD RESEARCH LETTERS

The basic letters are \$50.00; sales letters with a document are \$65.00; and research letters run from \$175.00 and up. **Note:** We were able to save all sales documents.

Research letters include USMC letters, OSS documents, 1st, 2nd, 5th, and 7th Cavalry, Civil War and Spanish American War documents. Other unique units require special research. More time is spent to travel to government facilities and comply with their rules for searching, copying, and the actual handling of documents.

A request for a document is done only at certain times at the Archives, and written requests must include numbers of Record Groups, location, and other data that is only

available on subject knowledge and specific document names and categories. We have been cross- checking many pieces of data and using U.S. Archives personnel and others to offer opinions on hard- to- read information. The Archives personnel have been very helpful in this area.

A basic letter is data recovered from our in-house files. It is limited, and there is no way for us to hold the thousands or millions of pages in the U.S. Archives.

This may require working with armed guards, checking our identification, and using special stamps for security classification or other rules.

Special documents require more time and may have higher costs.

U.S. Colt Model 1911, Serial Number 96514. Shipped to USS Hannibal AGI. July 26, 1938.

*USS Hannibal (AG-1), a converted steamer, was built as Joseph Holland by J. Blumer & Company at Sunderland, England, in 1898. She was purchased by the United States Navy on 16 April 1898 and renamed Hannibal. She was commissioned on 7 June with Commander Harrison Gray Otis Colby (USNA 1867) in command. During the Spanish-American

War, Hannibal participated in the Puerto Rico Campaign. On one occasion she and three other US ships bombarded the Spanish positions at the Battle of Fajardo. The ship was awarded the Spanish Campaign Medal and her officers and men were issued the Spanish Campaign badge for 1898 service.

From June 1898-May 1908, Hannibal served in the Collier Service along the Atlantic coast. After an overhaul in 1908, she continued in the Collier Service with her base in New England for nearly three years. Hannibal was decommissioned on 15 August 1911.

She was recommissioned on 16 October 1911 and was assigned to the U.S. Survey Squadron to make depth soundings and surveys in preparation for the opening of the Panama Canal. Hydrographic surveys continued in the Caribbean until 1917, including operations in Panama, Nicaragua, Honduras, and Cuba.

With the advent of World War I, Hannibal operated with the Patrol Force of the Atlantic Fleet. After an overhaul in early 1918, she became a tender to submarine chasers at Plymouth,

England. Hannibal served in English waters until December, when she sailed for the Azores via Gibraltar as a sub-chaser escort. In early 1919, she resumed sub-tender duties, and visited England, France, and Portugal returning to the United States in August.

Hannibal remained in reserve during which she was classified as a "miscellaneous auxiliary" in July 1920 with the hull number "AG-1" at Philadelphia until 9 February 1921,

when she sailed for Cuba to resume survey operations which lasted until 1930. During the next decade Hannibal surveyed waters near Trinidad, Venezuela, Costa Rica, and the Panama Canal Zone.

In 1933, Hannibal and Gannet were the first U.S. Navy vessels to collect dynamic sounding data in which depth and oceanographic data were collected in one sounding and analyzed aboard. Hannibal was replaced in its work for the U. S. Navy Hydrographic Office by Bowditch.

During World War II, she operated out of Norfolk, Virginia in the Chesapeake Bay degaussing range. Hannibal was decommissioned on 20 August 1944 and was sunk as a bombing target on 1 March 1945, in the Chesapeake Bay, just to the northwest of Smith Island, Md.

After 21 years of use as a target ship, the "Hannibal" was largely obliterated. In 1966, the Navy brought in a second target ship, the "American Mariner," a disused World War II Liberty ship, and sunk it next to the "Hannibal." Although the "American Mariner" is currently the U.S. Navy's only active live-fire target ship in the Chesapeake Bay, by tradition it keeps the name of the original target ship on that site and is still referred to as the "Hannibal."

***Editor's note:** Springfield Research Service has tried to maintain the original type of military wording and not convert the text to any current type of wording.

We try to maintain as much as possible of the writing made at the general time of publication by the U.S. military. The purpose of this text is to show what the feeling was as the ship went through the

transition from an English manufactured ship to an American vessel and show many of the historic moments that the Hannibal was involved in over a very long time in American history.

The Hannibal still exists and is sunk in a well-worn condition in the Chesapeake Bay in Maryland.

It was a target ship and was sunk right near the very historic Smith Island where early English language is still spoken.


Springfield Research Service has uncovered quite a few other histories that show the use of weapons used in the Spanish American War. The State of Virginia had extensive planning for an expected attack by Spanish battle ships in the Hampton Roads, Norfolk and other areas of the Chesapeake Bay and Atlantic shorelines.

Virginia's millions of dollars paid on defenses was a matter of debate in Congress concerning repayment of expenditures that they claimed should be shared by all states. The Richmond Times newspaper ran daily accounts of the expected Spanish Naval attacks. SRS has searched and found published college thesis documents with extraordinary details of type of weapons and military personnel and physical locations. Details include the use and issue of U.S. Springfield rifles during the Spanish American War.


U. S. Antique Commercial Arm Made by An American Civil War Manufacturer.




Above: Original percussion lock and original rear sight.


Below: Octagon barrel with nicely fitted metal forend cap.



Below: Lock marked P. S. J. & Co Warranted.




Below: Butt Stock with crescent brass butt plate and cheek piece.

Full octagon barrel with front sight blade. Barrel is 31 7/8 inches long.




Above: Lock is 4 3/4 inches long with large brass trigger guard providing extra space for finger.

Below: Left side of stock and single iron bolt for use with a small brass escutcheon. The cap and ball system circa 1850 with original percussion ignition.




Below: The single wedge holding a fixed quality made forend cap is shown with metal ramrod channel and original wooden ramrod.






Below: Closeup of five and $\frac{1}{4}$ inch quality made brass patch box with four well fitted steel screws.






The P. S. Justice has an octagon barrel that measures .43 in the bore. The antique half stock is held on the forend by a well-made metal cap with a single wedge and a single ferrel fixed to match the barrel contour. The barrel length of thirty-one 7/8 inches has a sight space of twenty-one $\frac{3}{4}$ inches front rear sight to front sight.

These fine condition American made antique long arms are still readily available at many gun-shows and auction houses. Care should be taken that the best condition weapons should be chosen and checked by qualified gun smiths.


Current modern made similar modern items are often much more in price and are in demand by hunters.

Both modern and antique long arms fire black powder and manufacture cleaner variations. Demand for caps and nipples are still available along with cleaning chemicals and equipment.


Joslyn Carbine number 8 is a very early carbine marked on the top of the breech block and is documented to Company H 19th New York Cavalry on September 25, 1863. There is another single number on the other side of the breech block. There are no other numbers on the carbine. The conversion carbine shows a process that used 1863 carbines as well as later guns. Very little data is known about the serial number process. There is no number on the lock plate. It is unknown what the number 2 indicates or if it is part of the serial number process.




Above: Front sight and muzzle.




Above: Top Joslyn conversion action open with rear sight.

Below: Butt plate with U.S. markings.




Above: Close up of action that is open showing conversion of an early production cartridge.

****Editor's note:** The above documents were made available from U.S. military sources on the internet. They are in the original military form and writing style at the time. They are in a listing series of military activity during the American Civil War.

They cover 1862 through 1865.

The New York Mounted Rifles Regiment was very active in a significant number of military operations and battles in Southern States.

Markings on the Carbine include: Lock JOSLYN Arms Co. 1864. Butt marked U.S. Block marked B.F. Joslyn Patent October 1861 June 24 1862. Top of Block 8 on the left, right side number 2. The caliber was .52 rimfire. The top of the barrel is marked R H.




Below: Right side with lever, rear sight, hammer, magazine assembly.



Below: Top side closed action, with serial number area, and rear sight.






The following documents are loose leaf copies of Springfield Research Service that were enhanced from original U.S. Archive records. They may be the only copies that are now available due to losses of Henry rifle records. The Archives are closed until a projected 2022 reopening that may confirm or show what records still exists.




The name of the Soldier that was issued Henry number 2076 appears to Thomas Tainer (or Trainer). The rifle data came from Company H, the 3rd Veterans Volunteer Infantry.

The documents were copied by U.S. Archives personnel who charged a nominal fee and used Government copy machines.

At that time the U.S. Martial Arms Collector Magazine editor was not allowed to use a personal camera. We have no idea if we can again have the permission to see the original documents that we fortunately kept in our private files.





