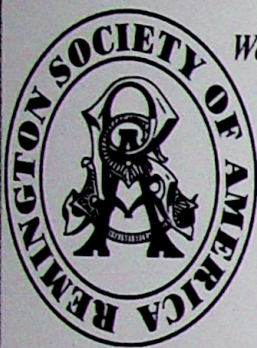

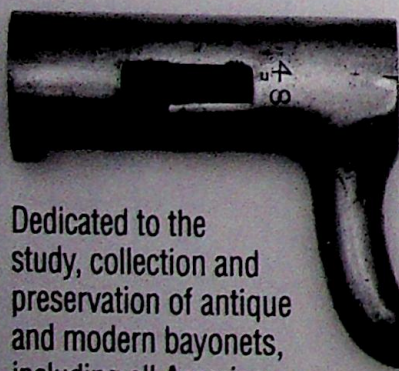
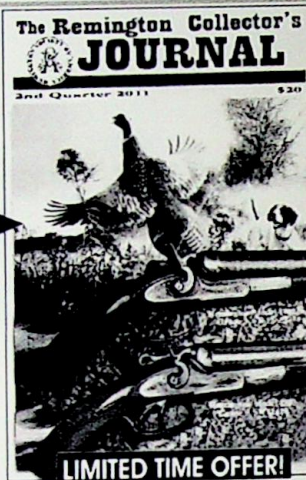

MISCELLANEOUS NOTES.

The U.S. Martial Arms Collector is reviewing many of our previous data findings. We want to ensure that any older research areas are examined to determine if we can locate more serial numbers. The task will take quite a while, but we hope that new areas will show up with more data that can be cross-correlated to give a more accurate data base. We have found some more Krag data that led us to U.S. Army records for the NRA Krag carbines. So far, we have found some very accurate serial numbers that identify known numbers for Carbines sold from Army supplies. They would be the serial numbers of rifles altered to a 22-inch carbine with altered stocks, and some data on the method of shortening the barrel and altering the end of the barrel for the 1905 Springfield Model front-sight sleeve.

Others areas include some data on a similar project that had Benecia Arsenal modify Model 1917 rifles to sales rifles. The 1917 Enfield was offered with at least 2 different receiver sights, a modified stock, and other minor modifications. The guns are very seldom found and are often mistaken for a cut-down variation by the civilian owner.

The Harpers Ferry arsenal records are being reviewed to determine if more data can be found on the serial numbers of some Flintlock muskets. The numbers used Roman numerals and we have found some unit data, but no data on weapons issued to an individual. It is hoped that the limited data and Roman numeral list will lead to more accurate numbers that can be traced to the original markings and their issue data as well as possible individual issue data. The search may also uncover any new information on other arsenals or specifically Springfield Arsenal weapons.

These efforts are ongoing and offer some indirect areas that may allow us to gather more data on arsenal records that may state direct or indirect procedures that lead to more weapon-manufacturing information. This will also provide other data on arms manufacturers that sold weapons to the United States military. This may also show sales to units, arsenals, or other parts of the Federal government, such as civilian agencies.

It is hoped that we can resume efforts to translate more of Colonel Sam Colt's letters to the War department in the 1847-to-the Civil War era. The letters are handwritten and take a day to understand the exact words for each letter.

We will also review the Civil War data of many units to examine areas for more accurate issue data for individual soldiers and their weapons. Many times, we can only find information on a certain type of carbine, rifle, or hand-gun issued. They often show only the fact that an issue was made to an individual or to a unit in terms of weapon type and number of weapons. No serial numbers are listed. We are searching for other documents that may have a serial number with soldiers names. Many documents have been found with serial numbers and no soldier's name and others of soldiers with no serial number listed.

Our efforts will be made to examine more units in wars and operations to gain more direction for data on indirect information on individual names. Some efforts have been slowed down because of National Archives search procedures, but other areas have offered better data based on prior work. We will try to find the best ways to gain information.

Research Books

There is no doubt that the gun-collecting professional and many collectors have found the availability of many more books and pamphlets that can aid in the information process. This is an area that has now blossomed in the age of the Internet. There are many more sites that have comments and facts that can be examined. There are also many comments that are unverified and need additional data to use in a search for details on a weapon.

The quality of many new books is excellent, and, many areas never in print have evolved and provided a great library for collectors. They do require the ability to afford the books and a place to store them to allow data searches. It appears that we have more data available that can be easily examined in a quick and useful way.

The sources that offer buyers new acquisitions are still the gun shows, the dealers, word-of-mouth information, and the Internet. The catalogs from auction house provides a major source of data for a buying capability to find, evaluate, and estimate current costs and many other factors for a collector.

Older catalogs offer historic data on where a gun has been, current location, condition and sales price. The catalogs also provide details of the condition at a specific time and any changes made over the years. It takes a lot of storage and data to have an easy-to-use compilation of sales, conditions and history.

Inquiries

We still receive letters and emails. SRS is always behind in this area, as it takes a great deal of time to research our files. We still have files in single-page document form. This is always of interest as it gives us data on readers' interests and also provides the requirements from our readers. We look forward to any comments and questions. This will keep us busy, but we want to keep them coming.

SUBSCRIPTIONS

NOTE. Please send an email if you receive any subscription data that is incorrect. We have had many problems with the Postal Service and need any comments or corrections for your magazines or letters. SPRINGFIELD RESEARCH LETTERS

We are writing more letters for our subscribers. The basic letters are \$50.00; sales letters with a document are \$65.00; and research letters run from \$175.00 and up. This includes USMC letters and OSS documents.

We are still way behind in research letters. There may be additional costs for most early Colts used in the Civil War and by the 1st, 2nd, 5th, 7th Cavalry, the Spanish American War, and other unique units. This is a result of extensive time to travel and verify a single document that is stored in

random documents that may run into millions of pages.

A basic letter is data recovered from our in-house files. A research letter requires us to travel to a government facility and request to search and retrieve the specific copy. We try to copy the specifics and include them with the letter. In many cases the data is a peculiar size and must be handled, verified, and copied according to government regulations.

This may also require working with armed guards, identification, special stamps for security classification or other rules.

Letters are based on best-available data located by SRS and National Archives and best efforts by SRS. Subscribers and others rely on this information at their own risk.

BACK ISSUES OF THE U.S. MARTIAL ARMS COLLECTOR MAGAZINES

SRS Searches.

We still find data on most areas of U.S. Arsenal and contractor firearms, accoutrements, bayonets and other production information. New data on the Enfield 1917 rifle, U.S. Krag, and test weapons still show up.

GUN SHOWS

Gun shows are continually changing. New shows are opening, old shows change hands, and many shows have changing characteristics that attract different variations of collectors.

It is wise to make sure a show is going on at a specific time and place before driving to a location.

The general areas include hunting, modern, antiques, and defense that emphasize their major theme. Cost to run and manage a show is a primary factor for continued operation and the split is usually between older established shows offered by gun clubs and commercial shows that are established for pure business and trade purposes.

He was medal of honor on the wáter bargade. Buried in King, WI. Please let me know if you have information of this carbine. I've been searching for 3 years. Thanks.

Please send the serial number for your carbine. We need the number to check and see if we can do any research. We may be able to search for the name and gain some data to look for another type of document. Editor.

Have you found any information on the early Trapdoor serial numbers? I have a US Model 1868 that needs some TLC but before I do anything I wanted to try and see if any history is available. So hoping there is information available,

here is my information: US Model 1868 Springfield 3rd Allin dated 1870 sn 14932.

We have searched both 45/70 trapdoors and 50/70 trapdoors and have not found your number. Please let me know if you found the number on the side of the frame or barrel, or if you found a number on the frame near the tang. We will look again if there are other markings. Editor.

Please let me know if you have any data on my trapdoor. It was sold to me as being in the carbine range for a 7th Cavalry gun.

We have no data on that carbine. Be very cautious of any description as" in the range". There were Congressional inquiries to Springfield Armory for specific numbers and the answers showed that single cases of 10 carbines had no consecutive numbers and many cases showed hundreds of numbers apart from each other. I notice on your website that you have some back issues of the 'Martial Arms Collector'. I would be very interested obtaining #116 which has info on Henry Rifles. I am trying to find out who #2648 might have been issued to, probably in the 66th ILL. Co.D, and thought this document might have some clues. I would like to purchase that issue if available. Good Afternoon, I recently bought a Springfield Armory M1 Garand and was wondering if you had the capability to look up the serial number so I could have some information about the rifle. Any help you can give will be appreciated.

Please send the serial number and we will check if we have information or if we can get information. The U.S. Army will not release many numbers of Garands, Carbines and 1911 Pistols. Editor.

As I continue to mull over the process of tracking down the history of any gun I wonder if you or others who do research on guns keep a record of the requests made by serial number. This type of record, while somewhat limited, could be defined as "modern" and of limited value yet, could become valuable to some future generation.

We may be able to search most requests but it will be a very big task that would also lead to a bigger task to sort and store with a retrievable capability. We have no plans to do this at this time. Editor.

Editors Note: We receive many emails and many do not relate to U.S. Martial Arms Collector issues.

All are answered but the context of some questions can only be answered with data that we have at hand or we are able to suggest other action.

Many inquiries are for commercial weapons that have the words Springfield, Massachusetts or similar phrases.

SRS has no data on commercial or foreign-made weapons unless they have a direct bearing on use by American Military units.

We do have plans to examine ammunition data such as U.S. and possibly foreign headstamps. This information is in various forms and requires editing and reprinting.

Selecting and making the final product always requires a decision to make a major effort or to cancel because of an unknown demand by our readers.

Areas such as prices and cost evaluations are always a part of inquiries. We cannot put a price or cost on any weapon. The most obvious reason is the lack of ability to inspect a weapon, all parts, finish, original factory or arsenal work and other factors.

We can often judge a general area of history to make general statements on rarity according to know production numbers and general survivability estimates of many weapons. There are other professionals who buy and sell or know of sales in the weapons markets. These individuals are more capable of costing and sales of martial items.

SRS wants inquiries and data on any mistake, address changes, and anything that can aid in quality control. The delivery of the magazine is of prime importance and we need any input that will make our products delivered to all addresses by first class postal delivery.

**THE JOURNAL OF CAPT.
NATHANIEL DWIGHT OF
BELCHERTOWN, MASS., DURING
THE CROWN POINT EXPEDITION,
1755.**

This journal was first published in The New York Genealogical and Biographical Record for 1902, [January and April]. It included original account of the battle of Lake George (Sant Sacrament) and subsequent history with names of prominent officers and a record of the dimensions of Fort William Henry that was captured during the French and Indian war. It was described by by Fenimore Cooper in "The Last of the Mohicans". (Printed by Tobias A. Wright, New York 1902).

Capt. Nathaniel Dwight, the author, was the son of Nathaniel Dwight of Northampton, Mass., and Mehitable Partridge, daughter of Col. Samuel Partridge of Hatfield, Mass. He was born June 20, 1712, in Northampton, and died March 30, 1784, in Belchertown, Mass. He served as Captain in the French and Indian War and was commissioned Captain, Sept. 10, 1755. On Aug.9, he marched for the relief of Fort William Henry and was attacked by an army of French and Indians under Montcalm.

The Journal of Captain Dwight has an extensive day-by-day account of many details of The French and Indian War. The daily life of the soldiers, the hardships and the weather are given in great detail. Items such as the October 1755 Scalping of men and many major battles with the movements of men from different named colonies.

(Please note that many words and phrases are shown as they were originally written. No changes were made to change the unique and historic data on the French and Indian War. A few examples of this have been taken from the 19 page journal written by an American Captain and data is shown in the writing of the day.)

In April 1755 they began to Raise forces for an expedition to Crown Point. The provinces of Connecticut, New York, Rhode Island, and New Hampshire joyn together in the expedition. They were till August or October 1755.

Scalped there as they were scattering Carlesly along the road. Col. [Samuel] Willard [Jr.] of Lancaster buried this morning

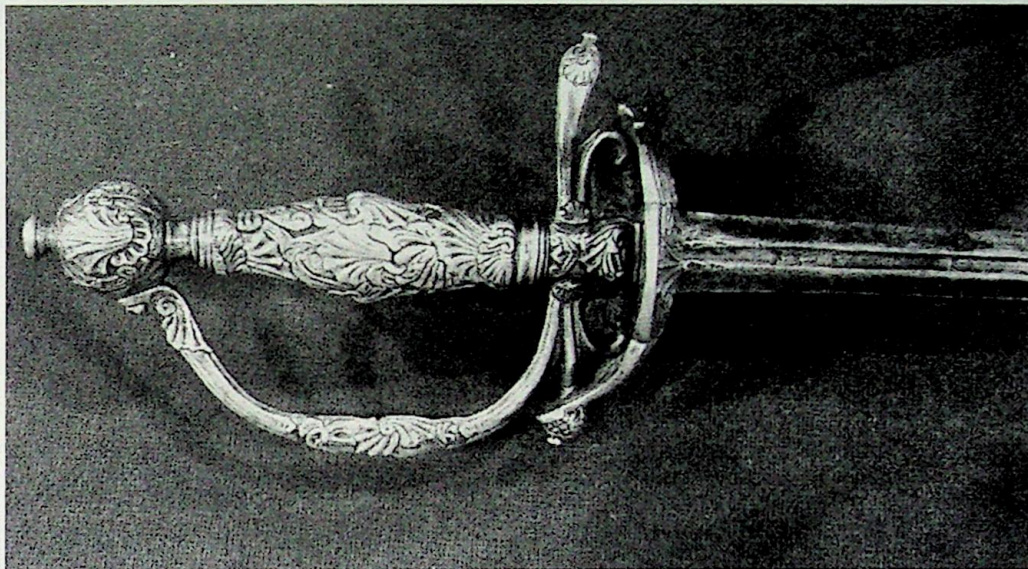
Officer of the Day for to-morrow. Orders: that 30 men from the Massachusetts troops 22 from Connecticut troops 18 from New York 12 from New Hampshire and 10 Rhodeisland with a Commission officer for each Detachment Do for the week haul up all the battoes over the bank in to the Swamp in Such a manner as not to be a Shelter to the enemy and to be under the Cover of the Guns of the fort. That 232 men officers included out of the Massachusetts Troops 193 men officers included out of the Connecticut Troops 154 men officers included out of the New York Troops 95 men, officers included out of the New Hampshire Troops and 76 men officers included out of the Rhode Island troops be given to Garrison Fort William Henry and Fort Edward which body of men are to be Considered as a Regiment of which Jon[athan] Bagley Esq to be Coll Nathan Whiting Esq to be Lieut Coll and Edmun Mathews Esqr to be Majr. 430 of the s[ai]d Regt under the Command of Lt Coll Whiting to Garrison Fort Edward.

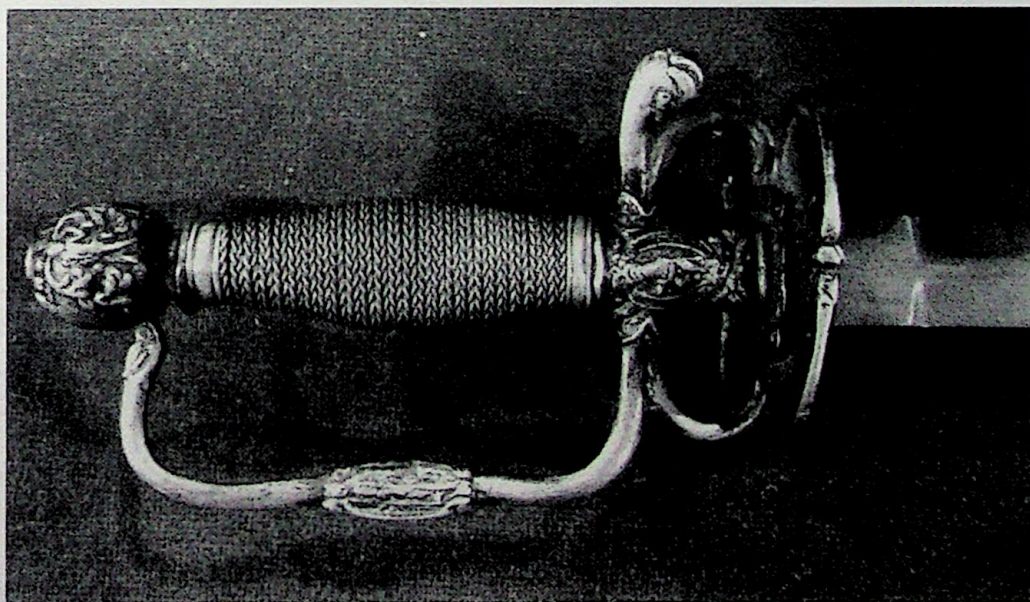
Swords of the French and Indian Wars Era in Colonial America.

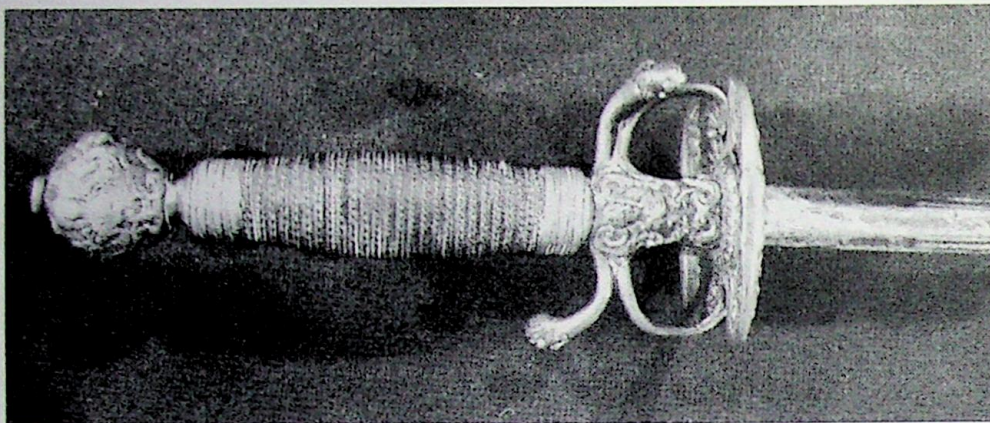
Below: Transitional Rapier. Seventeenth Century blade, made in Toledo, with early eighteenth century Continental Rococo Hilt.



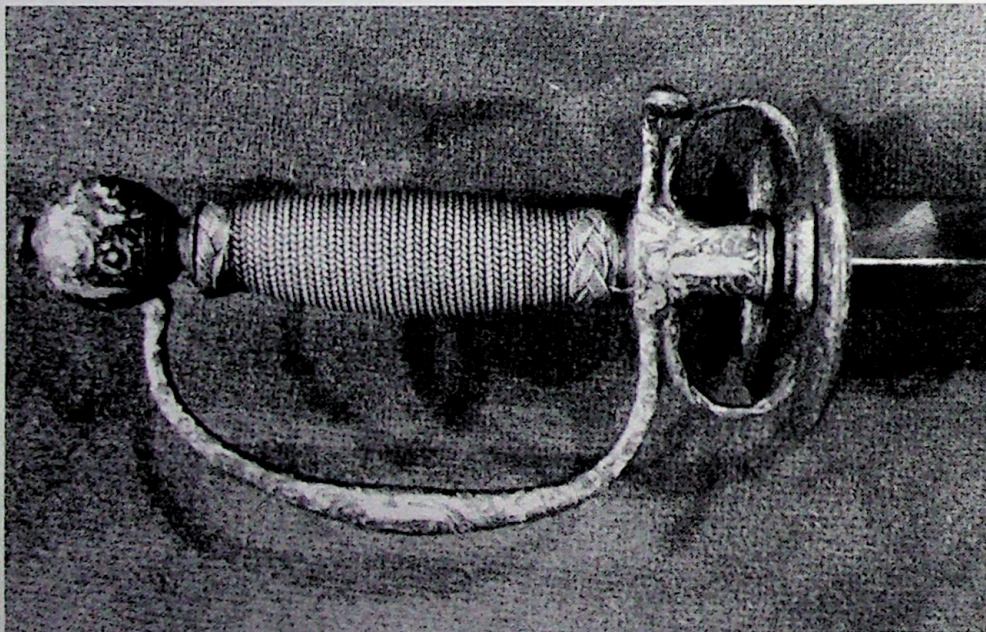
Below: Officer's Small Sword with late Rapier Blade, Circa 1710.

Blade, Circa 1740.



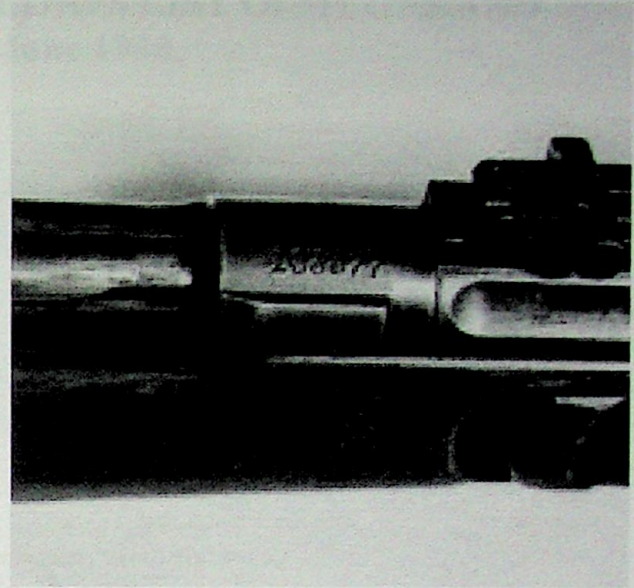
Below: Small sword with Gold inlay

1740.



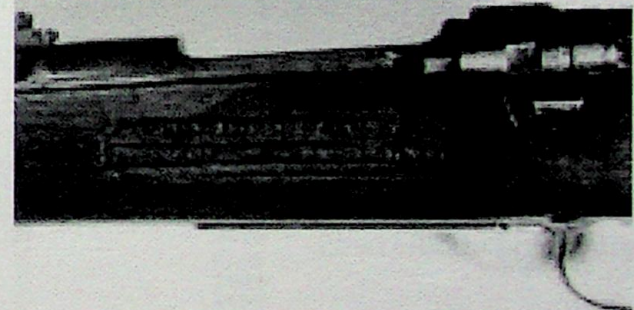
Springfield model 1903 Rifle With Modifications To The Firing Assembly and Stock.

Extensive modifications were made to require that the fore end be used as a slide action before each round was fired. The modifications included considerable work internally on the rifle.



Right: Stock machined out on left side of stock allowing visibility of slide action in use. It appears that the rifle is in original issue condition except for the action and stock modifications.

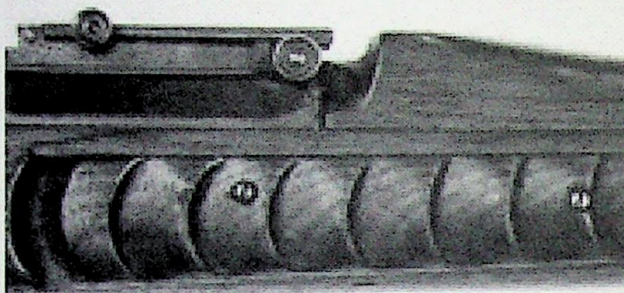

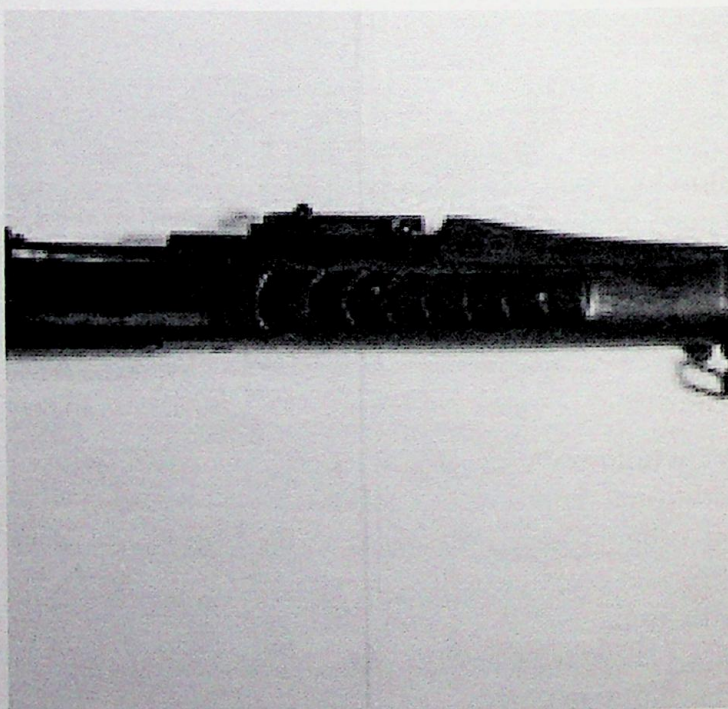

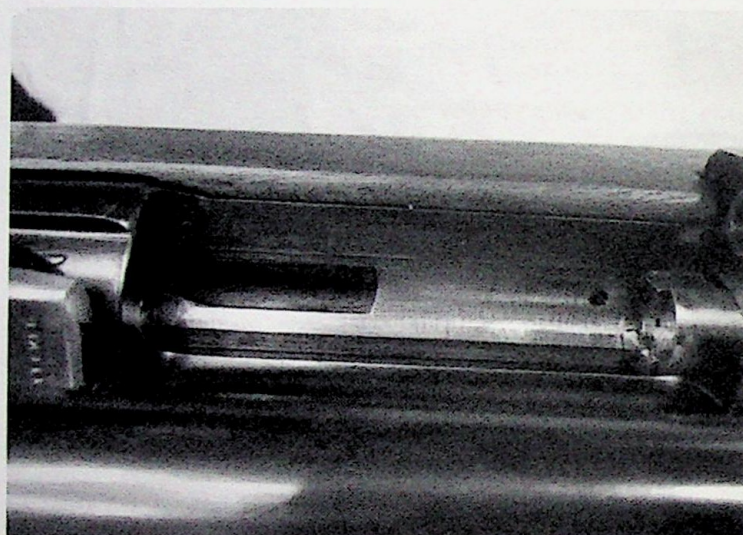

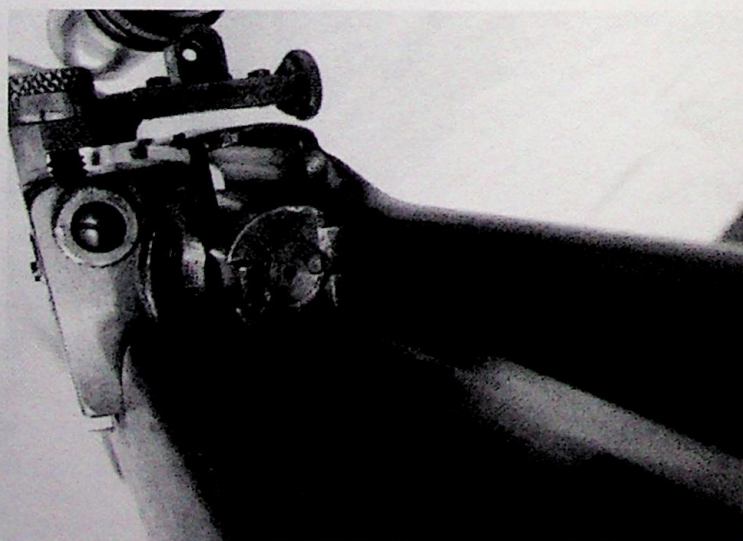

Right; The top view of the 1922 receiver.

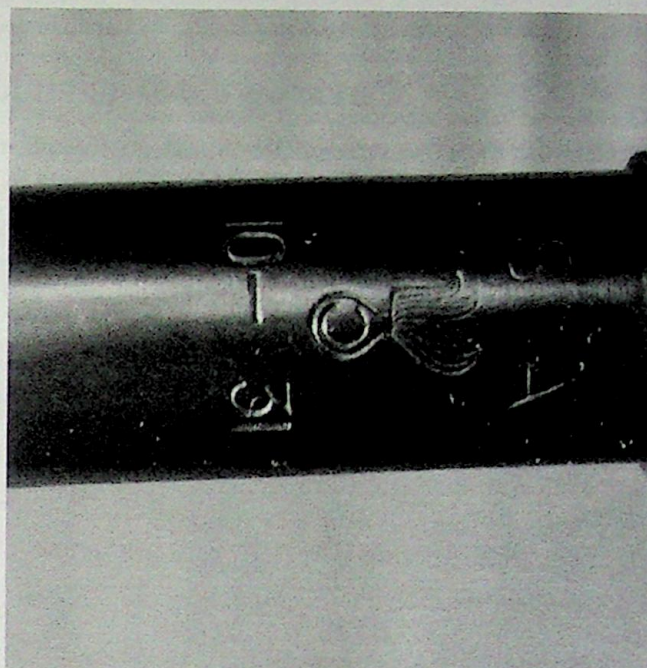

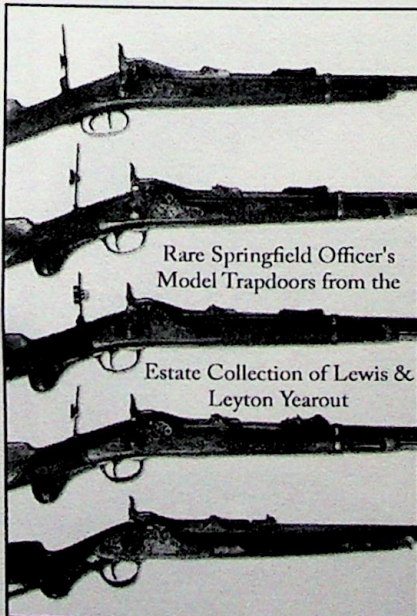
